Background

The Department of Public Works utilized sewer lateral lining for main and building sewer lines for several years with great success. The sewer lateral lining process is used when a sewer lateral needs repair due to extensive root growth, cracks or other defects that can be remedied without replacing the pipe, thus reducing restoration costs and inconvenience to the residents. However, there are instances when replacement is the only method that will correct the pipe failures. This replacement is only down when lateral lining is not an option.

The lining process essentially inserts a new pipe inside the existing pipe without excavation. The Public Works Department conducted a pilot project in 2005 to evaluate the T-Liner process and found it to be acceptable. The T-Liner lines a portion of the sewer main at the connection and shoots a liner up the lateral to the clean out.

The Department of Public Works solicited Requests for Proposals for Sewer Lateral Lining on September 7, 2017 and received two proposals in return. Performance Pipelining of Ottawa, IL was the lowest qualified bidder. Performance Pipelining has business with the Village of Lombard for sewer lateral lining in the past in which their work was acceptable to the Village. Enclosed is the proposal tabulation for the FY 2017 Sewer Lateral Lining Project highlighting Performance Pipelining as the lowest qualified bidder. The two submitted bids are as follows:

Contractor	Bid
Performance Pipelining – Ottawa, IL	\$43,700.00
National Power Rodding – Chicago, IL	\$68,500.00

The Water and Sewer Capital Reserve Fund has a budget of \$55,000 for Sewer Lateral Lining in RM PROG 13. The quantities in the proposal are estimates in order to obtain pricing and work orders will be issued to identify the locations and quantities to remain within budget. Payment for work performed will be based upon measured quantities multiplied by the contract unit prices.

The FY2017 Bid Document allows for a one-year extension of the contract of both parties agree to the same terms and conditions of the original contract. Both the Village and Performance Pipelining are in agreement and wish to extend the contract for 2018 at the original contract terms.

Recommendation

Please request the Board of Trustees to award a contract in the amount of \$43,700 for FY2018 for sewer lateral lining to Performance Pipelining Inc. of Ottawa, IL at their July 19, 2018 meeting.

FY 2018 Sewer Lateral Lining Project

This agreement is made this 19th day of July, 2018 by and between, and shall be binding upon, the Village of Lombard, an Illinois Municipal Corporation hereinafter referred to as (the "Village") and Performance Pipelining Inc. hereinafter referred to as (the "Contractor").

Witnesseth That in consideration of the mutual promises of the parties delineated in the Contract Documents, and herein, the Contractor agrees to sell and install and the Village agrees to pay for the following described items and the installation of the same as set forth in the Contract Documents:

Provide labor, equipment and materials for sewer lateral lining in an amount not to exceed
\$43,700.00 FY 2018

1. This Contract shall embrace and include all of the applicable Contract Documents listed below as if attached hereto or repeated herein:
 - a. Request for Proposal for FY 2017 Sewer Lateral Lining Project consisting of the following:
 - i) Cover Sheet
 - ii) Table of Contents
 - iii) Solicitation Letter
 - iv) General Terms, Conditions and Instructions
 - v) Specific Terms, Conditions and Instructions
 - vi) Proposal Form
 - vii) Plans and Specifications and Specification Deviation Form
 - b. The Contractor's Proposal Dated September 22, 2017
 - c. Documentation of honoring schedule of pricing for FY 2018
 - d. Required Certificate of Insurance

2. The Village agrees to pay, and the Contractor agrees to accept as full payment for the items, and installation of the same, which are the subject matter of this Contract, in accordance with the provisions of the Local Government Prompt Payment Act and the provisions of the Contract Documents.
3. Risk of loss, destruction or damage of or to goods under this Contract shall be on contractor until installation and acceptance of the goods by the Village.
4. Contractor shall not delegate the duties involved in the performance of the installation services which are the subject matter of this Contract without the written approval of the Village.
5. The Contractor represents and warrants that it will comply with all applicable Federal, State and local laws concerning prevailing wage rates regarding installation services provided under this Contract and all Federal, state and local laws concerning equal employment opportunities.
6. Time is of the essence of this Contract and Contractor agrees to achieve completion of the work order within the Contract time by all proper and appropriate means including working overtime without additional compensation.
7. In executing this Contract, Contractor agrees that it has examined the site of the work and the conditions existing therein, has examined the Contract Documents and taken and compared field measurements and conditions with those Documents.
8. This Contract represents the entire agreement between the parties and may not be modified without the written approval of both parties.
9. Where the terms of this Contract conflict with the provisions of the Contract Documents, the Contract Documents shall be binding.
