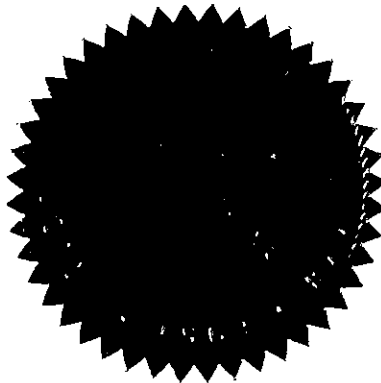



**ORDINANCE AMENDING THE LOMBARD TRAFFIC CODE**

WHEREAS, the President and Board of Trustees of the Village of Lombard have heretofore passed and approved Ordinance 1186, An Ordinance Regulating Traffic in the Village of Lombard (hereinafter the Lombard Traffic Code); and

WHEREAS, the President and Board of Trustees of the Village of Lombard find that the Lombard Traffic Code has been amended from time to time; and

WHEREAS, the Transportation and Safety Committee has reviewed the appropriate traffic studies and recommends certain changes to the Lombard Traffic Code; and

WHEREAS, the Corporate Authorities of the Village of Lombard concur in the recommendation of the Transportation and Safety Committee.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, as follows:

Section 1: That Schedule X (a) of the Lombard Traffic Code (Ordinance 1186) entitled PARKING TIME LIMITED ON CERTAIN STREETS be amended to add the following thereto:

<u>Name of Street</u>	<u>From</u>	<u>To</u>
Eugenia, north & south side	east curb line of West Road	west curb line of Elizabeth Street

Section 2: That Schedule VIII (m) of the Lombard Traffic Code (Ordinance 1186) entitled PARKING TIME PROHIBITED DURING CERTAIN HOURS ON CERTAIN STREETS be amended to add the following thereto:

<u>Name of Street</u>	<u>From</u>	<u>To</u>
Hammerschmidt Ave., east & west side	north curb line of Central Ave.	south curb line of Taylor Road
Ann Street, north side	west curb line of Main Street	east curb line of Lincoln Street

Section 3: That Schedule VIII (m) of the Lombard Traffic Code (Ordinance 1186) entitled PARKING TIME PROHIBITED DURING CERTAIN HOURS ON CERTAIN STREETS be amended to delete the following therefrom:

<u>Name of Street</u>	<u>From</u>	<u>To</u>
Hammerschmidt Ave., east & west side	south curb line of Wilson Avenue	north curb line of Central Avenue

Section 4: That Schedule IV of the Lombard Traffic Code (Ordinance 1186) entitled STOP STREETS be amended to add the following thereto:

<u>Name of Street</u>	<u>Shall Stop At</u>	<u>Name of Street</u>
Taylor Road, eastbound	“	Entrance to Park District Property

Section 5: That Schedule XXII (a) of the Lombard Traffic Code (Ordinance 1186) entitled NO BUS, STOPPING, STANDING OR PARKING be amended to add the following thereto:

SCHEDULE XXI - NO BUS, STOPPING, STANDING OR PARKING

(a) In accordance with Village of Lombard Ordinances, no bus, stopping, standing or parking are prohibited at the following locations:

<u>Name of Street</u>	<u>From</u>	<u>To</u>
Wilson Avenue, south side	east curb line of Edson Street	a point 1580 feet east

Section 6: That this Ordinance shall be in full force and effect from and after its passage, approval, publication in pamphlet form and the posting of appropriate signs as provided by law.
