Subject: Facility Cleaning Service, Village Hall, Police and Public Works

The Village of Lombard has participated in the Municipal Purchasing Initiative (MPI) contracts bid by the Village of Glenview for contract cleaning services.

The low bidder for the contract, Advanced Cleaning Systems has agreed to provide a proposal to the Village of Lombard for the cleaning of the Village Hall, Police Department and Public Works facility. Using the MPI contract has provided a savings over the current contract cleaning service. Proposals for the cleaning service had been sought from three other cleaning firms. Advanced Cleaning Systems provided a proposal for the lowest cost.

The current contract is expiring December 31, 2017. Advanced cleaning has indicated they would like to extend the contract for an additional year and have agreed to a reduction of services from the original contract. Under the new scope of services, the cleaning service will only attend to restrooms, garbage cans and kitchen areas on week nights, Monday through Friday. The common area - horizontal surfaces (excludes desks), floors and stairwells will be on a once a week schedule.

Staff has requested the reduction in service as part of the level of service cost reduction plan. The proposed contract represents a reduction of \$21,776.76 from the original 2016 cleaning contract.

Staff recommends approving the proposal from Advanced Cleaning Systems for an amount not to exceed \$39,291.24. If approved, Advanced Cleaning Systems will provide cleaning services beginning January 1, 2018 through December 31, 2018. Please present this item to the Board of Trustees at the January 4, 2018 meeting for their approval.
