ORDINANCE NO.

AN ORDINANCE AMENDING TITLE 3, CHAPTER 31 OF THE LOMBARD VILLAGE CODE IN REGARD TO VILLAGE PRESIDENT

BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

Section 1: That Title 3, Chapter 31 of the Lombard Village Code is amended by adding a new section 31.15, which shall read in its entirety as follows:

"§31.15 DESIGNATION OF PRESIDENT PRO TEM AND CHAIRMAN PRO TEM

The Village Board shall select from among the Trustees, a person to serve as President Pro Tem and Chairman Pro Tem, as set forth in Section 31.16 and Section 31.17 below, within sixty (60) days after each general consolidated election or after a vacancy in the office of the Trustee selected by the Village Board under this section. The selected Trustee shall serve until the selection of a new Trustee after the next consolidated election, or unless removed by a vote of a majority of the Trustees then serving on the Village Board, in which case the Village Board shall select a new Trustee under this section within sixty (60) days."

Section 2: That Title 3, Chapter 31 of the Lombard Village Code is amended by adding a new section 31.16, which shall read in its entirety as follows:

"§31.16 PRESIDENT PRO TEM

If a temporary absence or disability of the Village President or Acting Village President incapacitates him/her from the performance of his/her duties, but does not create a vacancy in the office, the Village Board has hereby determined that the Trustee selected pursuant to Section 31.15 above, shall act as President Pro Tem. The President Pro Tem, during the absence or disability, shall perform the duties and possess all the rights and powers of the Village President."

Section 3: That Title 3, Chapter 31 of the Lombard Village Code is amended by adding a new section 31.17, which shall read in its entirety as follows:

"§31.17

"§31.17 CHAIRMAN PRO TEM

If the Village President or Acting Village President is absent from a meeting, and the absence is not the result of a vacancy in office nor of such a nature as to require a President Pro Tem under Section 31.16 above, the Village Board has hereby determined that the Trustee selected pursuant to Section 31.15 above, shall act as Chairman Pro Tem for purposes of chairing said meeting. The Chairman Pro Tem shall have only the powers of a presiding officer and shall retain the right to vote in his/her capacity as Trustee on any Ordinance, Resolution or Motion."

Section 4: That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
