ORDINANCE 7100

**AN ORDINANCE AMENDING TITLE 11, CHAPTER 112,
SECTION 112.13 OF THE LOMBARD VILLAGE CODE IN
REGARD TO ALCOHOLIC BEVERAGES**

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES
OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS** as follows:

Section 1: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the “Class A/B-III” liquor license, contained therein, to read as follows:

Class “A/B-III” - 14

This decrease in Class “A/B-III” liquor license reflects a change in ownership of T.G.I. Friday’s #0063, located at 601 E. Butterfield Road, and the termination of the Class “A/B-III” liquor license issued to T.G.I. Friday’s Inc. in relation thereto.

Section 2: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class “A/B-III” liquor license, contained therein, to read as follows:

Class “A/B-III” - 15

This increase in Class “A/B-III” liquor licenses reflects the issuance of a Class “A/B-III” liquor license to Central Florida Restaurants, Inc. who is operating the business commonly known as T.G.I. Friday’s located at 601 E. Butterfield Road, Lombard, IL.

Section 3: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.


