 - b. The Contractor's Bid Proposal for FY 2012B Maple Street Concrete Rehabilitation Using Unit Prices from FY 2012B Concrete Rehabilitation and Utility Cuts Patching Dated: 05/23/2012
 - c. Required Performance and Payment Bonds and Certificate(s) of Insurance for FY 2012B Maple Street Concrete Rehabilitation
 - d. Executed Bidder's Certification Form for FY 2012B Maple Street Concrete Rehabilitation.
- 2. The Village agrees to pay, and the Contractor agrees to accept as full payment the amount as shown on the Contractor's Bid Proposal, which is made a part hereof, subject to such additions and deletions as agreed to by the parties hereto.

- The Contractor shall commence work under this Contract upon written Notice to Proceed from the Village and shall complete work under this contract within 60 calendar days from the date of the Notice to Proceed. Time is of the essence in regard to this Contract, and the Contractor agrees to achieve completion within the time permitted by all proper and appropriate means including working overtime without additional compensation.
- Pursuant to the provisions of Section 5 of the Mechanics' Lien Act of Illinois, prior to making any payment to the Contractor under this Contract, the Village demands that the Contractor furnish a written statement of the names of all parties furnishing labor and/or materials under this Contract and the amounts due or to become due each. This statement must be made under oath or be verified by affidavit. The Village shall not issue final payment nor shall any retained percentage become due until releases and waivers of lien have been supplied as the Village designates.
