Dyslexia Brewing LLC d/b/a Dyslexia Brewing – 109 S. Main St.**

The Village has received a request for a Class “SS” liquor license from Dyslexia Brewing LLC d/b/a Dyslexia Brewing located at 109 S. Main St. for the January 1, - June 30, 2023 license term.

Dyslexia Brewing is a craft alcohol production business that brews Beer, Cider, and Mead on and off site for retail sale and consumption.

The Board of Trustees recently approved an Ordinance granting conditional use to the owners of Dyslexia Brewing to operate a craft alcohol production facility at 109 S. Main St., within the B5PD Central Business District.

AN ORDINANCE AMENDING TITLE XI, CHAPTER 112, SECTION 112.13 OF THE LOMBARD VILLAGE CODE IN REGARD TO THE NUMBER OF CLASS "SS" LIQUOR LICENSES

BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

SECTION 1: That Title XI, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the language therein, relative to the Class "SS" liquor license category, to read in its entirety as follows:

"Class "SS" – 2"

This increase in the number of Class "SS" liquor licenses reflects the issuance of a new Class "SS" liquor license to Dyslexia Brewing LLC d/b/a Dyslexia Brewing, located at 109 S. Main St., Unit 104, Lombard, Illinois.

SECTION 2: That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, as provided by law.
