ORDINANCE _____

**AN ORDINANCE AMENDING TITLE 11, CHAPTER 112,
SECTION 112.13 OF THE LOMBARD VILLAGE CODE IN
REGARD TO ALCOHOLIC BEVERAGES**

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES
OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS** as follows:

Section 1: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "A/B I" liquor license, contained therein, to read as follows:

Class "A/B I" - 9

This increase in Class "A/B I" liquor licenses reflects the issuance of a Class "A/B I" liquor license to Bill Goat Tavern West, LLC who will be operating the business commonly known as Billy Goat Tavern & Grill located at 203 Yorktown (Yorktown Mall) Food Court 6, Lombard.

Section 2: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
