### VILLAGE BOARD POLICY MEMORANDUM

Subject: Driveway apron replacements	Number: 98-2	
I. Purpose	Effective Date:	
The purpose of this Board of Trustees policy is to clarify how the Village will perform driveway apron replacements located within the Village's right-of-way. The Village desires that a high quality uniform apron material be used to reduce maintenance and improve the appearance of village roadways.		
When it is in the Village's best interest to replace a driveway apron, it will do so within the guidelines of this policy. It is the intent of this policy that apron replacements will be considered as part of an adjacent construction project, not as a program offered to the general public		
II. Procedures/Guidelines		
A. The following events may warrant the replace utility or roadway improvement, 2) utility or roadway rep		
B. Apron material shall be concrete (for both concrete and asphalt streets) as specified by the Public Works Department, unless its use is cost prohibitive due to shortages, strikes, etc. Concrete will be placed at no additional charge to owner.		
C(1). Reconstrution projects will usually warrant the replacement of all aprons. C(2). During rehabilitation projects such as grind and overlays, selective curb replacement, and utility repairs, the Public Works Department will use their discretion in performing apron replacements and specifying material, including asphalt, considering the apron's condition, extent of disturbance, and availability of public funds. Concrete aprons will not be down-graded to asphalt. Sawed joints are acceptable at the discretion of the engineer; however, at owner's expense complete apron replacement will be offered to the owner at contract prices.
