**A RESOLUTION TEMPORARILY LIMITING PARKING  
ALONG ST. CHARLES ROAD  
BETWEEN MAIN STREET AND LINCOLN AVENUE**

**WHEREAS**, the Village of Lombard wishes to host and otherwise operate "Cruise Nights, with the cooperation of the Lombard Chamber of Commerce, on Saturday nights between June 7, 2008 and September 13, 2008 (excluding July 5 & August 30, 2008) from 5:30 p.m. to 10:30 p.m.; and,

**WHEREAS**, it is necessary to limit parking along St. Charles Road between Main Street and Lincoln Avenue and along Park Avenue between Orchard Terrace and Michael McGuire Drive, during the various "Cruise Nights" as described above, to allow for the event to take place;

**NOW, THEREFORE, Be It Resolved** by the President and Board of Trustees of the Village of Lombard, Du Page County, Illinois, as follows:

**SECTION 1:** That the portion of St. Charles Road between Main Street and Lincoln Avenue shall be closed to public parking on the following dates:

**SECTION 2:** That the "Lombard Chamber of Commerce," by and through one of its agents, shall determine at its sole discretion which vehicles participating in "Cruise Nights", if any, shall be allowed to park on the portion of St. Charles Road between Main Street and Lincoln Avenue, and on the portion of Park Avenue between Orchard Terrace and Michael McGuire Drive which is closed to public parking during the time periods designated herein.
