## Wilson Avenue Parking Restriction

The Public Works Department has previously received requests to continue the south side parking restriction on Wilson Ave west of Finley Rd to the Village limits, and the Committee previously reviewed this request. At that time, the Committee amended staff recommendation and enacted the restriction near the Finley intersection. The residents sent a petition to enact parking restrictions from 9 a.m. to 3 p.m. to the Village limits, and the petition contained the majority of affected residences. The restriction ends slightly west of Finley and resumes in the unincorporated portion. For uniformity and resident safety, staff recommended the restriction to include the portion between Finley Rd to the Village boundary (Highmoor Rd) in accordance with original staff recommendation.

During the November 2, 2015 meeting, the Public Safety and Transportation Committee voted to recommend adding the parking restriction in accordance with staff recommendation.

## Ordinance No.

WHEREAS, the President and Board of Trustees of the Village of Lombard have heretofore passed and approved Ordinance 1186, An Ordinance Regulating Traffic in the Village of Lombard (hereinafter the Lombard Traffic Code); and

WHEREAS, the President and Board of Trustees of the Village of Lombard find that the Lombard Traffic Code has been amended from time to time; and

WHEREAS, the Public Safety and Transportation Committee has reviewed the appropriate traffic studies and recommends certain changes to the Lombard Traffic Code; and

WHEREAS, the Corporate Authorities of the Village of Lombard concur in the recommendation of the Transportation and Safety Committee.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, as follows:

Section 1: That Schedule VIII, Section M, of the Lombard Traffic Code (Ordinance 1186) is amended to add the following restriction:

"Wilson Avenue from Village Limits to Finley Road."
