

AN ORDINANCE AMENDING TITLE 11, CHAPTER 110, SECTION 110.21(C) OF THE LOMBARD VILLAGE CODE IN REGARD TO THE NUMBER OF AUTHORIZED COIN-OPERATED AMUSEMENT DEVICE LICENSES

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DUPAGE COUNTY, ILLINOIS, as follows:

Section 1: That Title 11, Chapter 110, Section 110.21(C), of the Lombard Village Code is amended by revising the entry relative to the Class "A" coin operated amusement device license, contained therein, to read as follows effective September 22, 2003:

Class "A" - 4

This decrease in Class "A" coin operated amusement device licenses reflects the sale of the assets of Grandma's Pub Inc. d/b/a Flaherty's Beef & Brew and the termination of the Class "A" coin operated amusement device license issued to Grandma's Pub Inc. in relation thereto.

Section 2: That Title 11, Chapter 110, Section 110.21(C), of the Lombard Village Code is amended by revising the entry relative to the Class "A" coin operated amusement device license, contained therein, to read as follows:

Class "A" - 5

This increase in Class "A" coin operated amusement device licenses reflects the issuance of a Class "A" coin operated amusement device license to Karkel Inc. who will be operating the business commonly known as Flaherty's Beef & Brew located at 418 S. Main Street, Lombard.

Section 3: This Ordinance shall be in full force and effect from and after its passage and approval as provided by law.
