Chicago Blackhawks Viewing Event - May, 2014


Staff has received a request from Lombard Town Centre for a Chicago Blackhawks viewing event to occur between May 15 and May 31, 2014 and associated with the possible Blackhawks participation in the National Hockey League Western Conference finals. As the dates, time and opponent of the game(s) has not been determined to date, a date range is offered. Should the Blackhawks make it to the conference finals, staff will work with Lombard Town Centre and the participating businesses to formalize an appropriate viewing date. If the Blackhawks do not advance to the conference finals, the event will not occur. Staff is selecting the time period or May 15 through 31, as it is not likely that these dates would impact any pending construction activity by Metra and/or its contractors relative to the pedestrian underpass project.

To this end, attached please find the attached document relative to the above-captioned matter, for the May 15, 2014 Village Board Meeting:

- 1. The special Class "J" liquor licenses are exclusively for the proposed viewing event can only be issued should the Blackhawks make it to the Conference Finals.
- 2. The service of alcoholic liquor pursuant to the special Class "J" liquor licenses begins two (2) hours before game time, and ends thirty (30) minutes after the end of each game.

AN ORDINANCE AMENDING TITLE 11, CHAPTER 112, SECTION 112.18(B)
OF THE LOMBARD VILLAGE CODE IN REGARD TO ALCOHOLIC BEVERAGES,
PROVIDING FOR THE SALE AND CONSUMPTION OF ALCOHOL IN CONNECTION
WITH A TEMPORARY EVENT AT 11 AND 16 SOUTH PARK AVENUE,
BETWEEN MAY 16, 2014 AND MAY 31, 2014

BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

SECTION 1: That Title 11, Chapter 112, Section 112.18(B) of the Lombard Village Code is amended by adding a new subsection (7) thereto, effective upon the adoption of this Ordinance through 11:59 p.m. on Saturday, May 31, 2014, which shall read in its entirety as follows:

"(7) In light of the fact that Shannons on Park, Inc. d/b/a Shannon's Deli, located at 11 South Park Avenue, and Bill and Punky's Step Up Inn, Ltd. d/b/a Punky's Pub, located at 16 South Park Avenue, will be holding a single temporary event for the viewing of one (1) Chicago Blackhawks playoff hockey game, between May 16, 2014 and May 31, 2014, should the Chicago Blackhawks advance to the NHL Western Conference Finals. said liquor licensees shall each be eligible for a Class "J" liquor license, despite the fact that said liquor licensees are for-profit business entities, for the sole purpose of selling alcoholic beverages for consumption in a designated and secured area adjacent to each of said licensed premises, to be approved by the Village pursuant to the issuance of a temporary event permit under Chapter 110 of the Village Code, beginning two (2) hours prior to the start of a single Chicago Blackhawks playoff hockey game, between May 16, 2014 and May 31, 2014, should the Chicago Blackhawks advance to the NHL Western Conference Finals, and terminating thirty (30) minutes after the conclusion of said playoff hockey game. The liquor licenses to be issued under this subsection (7) may be issued by the Local Liquor Commissioner upon proper application to the Village, and satisfaction of all applicable requirements and conditions by the licensees. No liquor license shall be issued under this subsection (7) until such time as each licensee obtains the necessary temporary event permit under Chapter 110 of the Village Code and complies with all requirements and conditions thereof, including, without limitation, the insurance, bond and indemnification requirements of Chapter 110 for temporary event."

SECTION 2: That, effective at 11:59 p.m. on Saturday, May 31, 2014, Title 11,			
Chapter 112, Section 112.18(B)(7) of the Lombard Village Code, as set forth in Section			
1 above, is hereby repealed, without need for any further action by the President and			
Board of Trustees.			
SECTION 3: That this Ordinance shall be in full force and effect from and after			
its passage and approval as provided by law.
