**A RESOLUTION TEMPORARILY LIMITING PARKING
ALONG PARK AVENUE BETWEEN ORCHARD TERRACE AND MICHAEL
MCGUIRE DRIVE**

WHEREAS, the Village of Lombard wishes to host and otherwise operate "Cruise Nights, with the cooperation of the Lombard Chamber of Commerce, on Saturday nights between June 4, 2005 and August 27, 2005 (excluding July 2, 2005) from 5:30 p.m. to 10:30 p.m; and,

WHEREAS, it is necessary to limit parking along Park Avenue between Orchard Terrace and Michael McGuire Drive, during the various "Cruise Nights" as described above, to allow for the event to take place;

NOW, THEREFORE, Be It Resolved by the President and Board of Trustees of the Village of Lombard, Du Page County, Illinois, as follows:

SECTION 1: That the portion of Park Avenue between Orchard Terrace and Michael McGuire Drive shall be closed to public parking on the following dates:

June: 04	July: 09	August: 06
11	16	13
18	23	20
25	30	27

SECTION 2: That the "Lombard Chamber of Commerce," by and through one of its agents, shall determine at its sole discretion which vehicles participating in "Cruise Nights", if any, shall be allowed to park on the portion of Park Avenue between Orchard Terrace and Michael McGuire Drive which is closed to public parking during the time periods designated herein.

SECTION 3: That this Resolution shall be in full force and effect from and after its passage and approval as provided by law.
