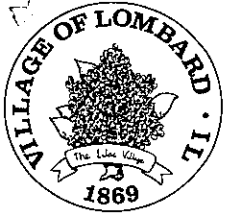

Please be advised liquor license holders with a Class A/B license are required to report their annual gross dollars of liquor sales yearly. Famous Daves located at 3 Yorktown Mall reported an decrease in their 2003 sales which changes their classification from a Class A/B III to a Class A/B II.

**ORDINANCE \_\_\_\_\_**  
**AN ORDINANCE AMENDING TITLE 11, CHAPTER 112,**  
**SECTION 112.13 OF THE LOMBARD VILLAGE CODE IN**  
**REGARD TO ALCOHOLIC BEVERAGES**

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES**  
**OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS** as follows:

Section 1: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class A/B II liquor licenses, contained therein, to read as follows:

Class "A/B II - 9

Section 2: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class A/B III liquor licenses, contained therein, to read as follows:

Class "A/B III - 8

Section 3: That the changes in the number of Class A/B liquor licenses set forth in Sections 1 and 2 above are as a result of Famous Dave's, 3 Yorktown Mall reporting an decrease in their gross dollars of liquor sales in calendar year 2003, resulting in a change from Class A/B III to Class A/B II.

Section 4: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
