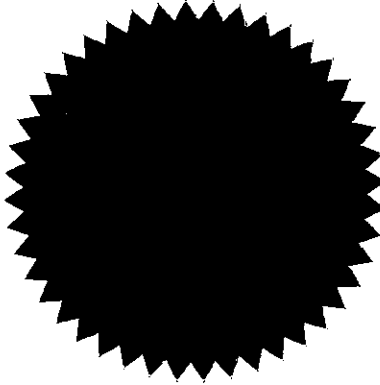

ORDINANCE NO. 5536

ORDINANCE AMENDING THE LOMBARD TRAFFIC CODE

WHEREAS, the President and Board of Trustees of the Village of Lombard have heretofore passed and approved Ordinance 1186, An Ordinance Regulating Traffic in the Village of Lombard (hereinafter the Lombard Traffic Code); and

WHEREAS, the President and Board of Trustees of the Village of Lombard find that the Lombard Traffic Code has been amended from time to time; and

WHEREAS, the Transportation and Safety Committee has reviewed the appropriate traffic studies and recommends certain changes to the Lombard Traffic Code; and

WHEREAS, the Corporate Authorities of the Village of Lombard concur in the recommendation of the Transportation and Safety Committee.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, as follows:

Section 1: That Schedule XIII of the Lombard Traffic Code (Ordinance 1186) entitled RIGHT TURNS ON RED TRAFFIC SIGNALS be amended to add the following thereto:

j) westbound traffic on Parkside Avenue shall not turn right on red onto Main Street between the hours of 6:00 a.m. to 9:00 a.m. and 4:00 p.m. to 7:00 p.m.

Section 2: That Schedule XIII of the Lombard Traffic Code (Ordinance 1186) entitled RIGHT TURNS ON RED TRAFFIC SIGNALS be amended to read as follows

f) eastbound traffic on St. Charles Road shall not turn right on red onto Main Street between the hours of 6:00 a.m. to 9:00 a.m. and 4:00 p.m. to 7:00 p.m.

Section 3: That Schedule X (d) of the Lombard Traffic Code (Ordinance 1186) entitled PARKING TIME LIMITED ON CERTAIN STREETS during the hours of 8:00 a.m. and 6:00 p.m. be amended to delete the following therefrom:

Name of Street	From	To
St. Charles Road North side	west curb line of Main Street	195 feet west of the east curb line of Lincoln Street

Section 4: That Schedule X (d) of the Lombard Traffic Code (Ordinance 1186) entitled PARKING TIME LIMITED ON CERTAIN STREETS during the hours of 8:00 a.m. and 6:00 p.m. be amended to add the following thereto:

Name of Street	From	To
St. Charles Road North side	60 feet west of the west curb line of Main Street	195 feet west of the east curb line of Lincoln Street

Section 5: That Schedule VII of the Lombard Traffic Code (Ordinance 1186) entitled PARKING PROHIBITED AT ALL TIMES ON CERTAIN STREETS be amended to add the following thereto:

Name of Street	From	To
St. Charles Road	west curb line of	60 feet west
North side	Main Street	

Section 6: That this Ordinance shall be in full force and effect from and after its passage, approval, publication in pamphlet form and the posting of appropriate signs as provided by law.




