Grass and Weed Mowing Contract Renewal

On December 5th, 2014, the Village of Lombard opened bids for the Village contract **PWO 15-17**, *Grass and Weed Mowing*. The lowest responsible bid was received from Green Horizon Landscaping LLC. The original contract was from April 1, 2015 to December 31, 2015 with two optional extension years.

We have contacted Green Horizon Landscaping LLC and they have agreed to honor their prices from the December 2014 bid for the 2017 calendar year. Green Horizon Landscaping LLC has provided good service to the Village over the last several years and responded in a timely manner when there have been areas of concern. The FY17 budget contains \$45,000.00 from Hotel/Motel and \$39,000 from the General Fund for mowing purposes.

Staff recommends renewing the Grass and Weed Mowing contract with Green Horizon Landscaping LLC for the amount of \$75,700.00. This is the last of two possible extensions of the contract and will expire December 31, 2017. Please present this item to the Board of Trustees at the January 5, 2017 meeting for their approval.
