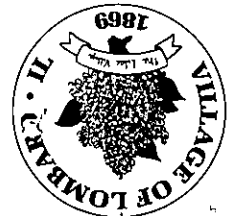

ORDINANCE

AN ORDINANCE AMENDING TITLE 11, CHAPTER 112, SECTION 112.13 OF THE LOMBARD VILLAGE CODE IN REGARD TO ALCOHOLIC BEVERAGES

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS as follows:

Section 1: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "A/B III" liquor license, contained therein, to read as follows:

Class "A/B III" - 16

This decrease in Class "A/B III" liquor licenses reflects the termination of LSG Food Services Inc. d/b/a Weber Grill Restaurant and the termination of the Class "A/B III" liquor license issued to LSG Food Services Inc. in relation thereto.

Section 2: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "A/B III" liquor license, contained therein, to read as follows:

Class "A/B III" - 17

This increase in Class "A/B III" liquor licenses reflects the issuance of a Class "A/B III" liquor license to Weber Grill Restaurants LLC, who is operating the business commonly known as Weber Grill Restaurant located at 2331 S. Fountain Square Drive, Lombard.

Section 3: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
