**ORDINANCE**  
**AN ORDINANCE AMENDING TITLE 11, CHAPTER 112,**  
**SECTION 112.13 OF THE LOMBARD VILLAGE CODE IN**  
**REGARD TO ALCOHOLIC BEVERAGES**

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES**  
**OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS** as follows:

**Section 1:** That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "A/B I" liquor license, contained therein, to read as follows:

Class "A/B I" - 4

This decrease in Class "A/B I" liquor licenses reflects the sale of the assets of The Grove Restaurant and the termination of the Class "A/B I" liquor license issued to The Grove Snack Shop Inc. in relation thereto.

**Section 2:** This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
