TITLE: Ordinance Amending Title 11, Chapters 110, 113, 115, 119, ,120, 121 and 122 of the Lombard Village Code in Regard to Business Regulation Fees.

BACKGROUND/POLICY IMPLICATIONS:

Attached is an ordinance that amends the Village Code as it relates to business license fees for FYE 2006. At their February 21, 2005 meeting, the Finance Committee voted unanimously to recommend to the Village Board approval of the FYE 2006 Proposed Budget. The budget as proposed includes increases for several license fees, as have been previously discussed with the Village Board at several budget meetings.

Below is a listing of the proposed fees:

- Coin-operated amusement devices - \$200 each for first 10 devices; \$75 for each additional device
- Alarm User - \$30 residential; \$50 commercial
- Filling Stations - \$250
- Restaurant/Food Handler - \$50
- Food Delivery Vehicle - \$50
- Tobacco Dealer - \$150
- Secondhand and Junk Dealers - \$50
- Junk Yard/Auto Wrecker - \$250
- Antique Dealer - \$50
- Taxi Company - \$250
- Massage Establishment - \$250

AN ORDINANCE AMENDING TITLE 11, CHAPTERS 110, 113, 115,  
119, 120, 121 AND 122 OF THE LOMBARD VILLAGE CODE  
IN REGARD TO BUSINESS REGULATION FEES

**BE IT ORDAINED** by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

SECTION 1: That Title 11, Chapter 110, Section 110.21(B) of the Lombard Village Code is amended to read in its entirety as follows:

“(B) Each coin-operated amusement device shall be separately licensed at an annual fee of \$200.00 per machine for the first ten (10) coin-operated amusement devices located on the licensed premises, and \$75.00 per machine for each coin-operated amusement device in excess of ten (10) located on the licensed premises.”

SECTION 2: That Title 11, Chapter 113, Section 113.05 of the Lombard Village Code is amended by revising the reference therein to, “ten and no/100 dollars (\$10.00),” to read, “thirty and no/100 dollars (\$30.00),” and by revising the reference therein to “twenty-five and no/100 dollars (\$25.00),” to read, “fifty and no/100 dollars (\$50.00).”

SECTION 3: That Title 11, Chapter 115, Section 115.02(C) of the Lombard Village Code is amended to read in its entirety as follows:

“(C) The license fee for each filling station shall be two hundred fifty and no/100 dollars (\$250.00) per year.”

SECTION 4: That Title 11, Chapter 119, Section 119.02(B) of the Lombard Village Code is amended to read in its entirety as follows:

“(B) The license fee for a restaurant license issued under this Chapter shall be fifty and no/100 dollars (\$50.00) per year.”

SECTION 5: That Title 11, Chapter 119, Section 119.11(B) of the Lombard Village Code is amended by revising the first sentence thereof to read in its entirety as follows:

“(B) The annual fee for such license shall be fifty and no/100 dollars (\$50.00) per vehicle.”

SECTION 6: That Title 11, Chapter 120, Section 120.05(A) of the Lombard Village Code is amended to read in its entirety as follows:

“(A) The annual license fee for a tobacco dealer’s license shall be one hundred fifty and no/100 dollars (\$150.00).”

SECTION 7: That Title 11, Chapter 120, Section 120.33 of the Lombard Village Code is amended by revising the reference therein to, “\$25,” to read, “fifty and no/100 dollars (\$50.00),” and by revising the reference therein to, “\$100,” to read, “two hundred fifty and no/100 dollars (\$250.00).”

SECTION 8: That Title 11, Chapter 120, Section 120.53 of the Lombard Village Code is amended by revising the reference therein to, “\$25,” to read, “fifty and no/100 dollars (\$50.00).”

SECTION 9: That Title 11, Chapter 121, Section 121.03(B) of the Lombard Village Code is amended to read in its entirety as follows:

“(B) Fees. The fee for a business license issued pursuant to this Chapter shall be two hundred fifty and no/100 dollars (\$250.00) per year. A late fee of two hundred fifty and no/100 dollars (\$250.00) shall be assessed in relation to any business license renewed after the renewal due date or obtained after Taxicab service has commenced.”

SECTION 10: That Title 11, Chapter 122, Section 122.03(A) of the Lombard Village Code is amended by revising the references therein to, “\$200,” to read, “two hundred fifty and no/100 dollars (\$250.00).”

SECTION 11: That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
