SUBJECT: Request for a Class “F” Liquor License
Shatki 11 Lombard, Inc. – 105 E. Roosevelt Road

Shatki 11 Lombard, Inc d/b/a Famous Liquor located at 105 E. Roosevelt Road currently holds a Class “F” liquor license. The primary purpose of this establishment is the sale of alcoholic liquors, not for consumption on the premises (Package Store).

The Village has received a request for a Class “F” liquor license from the new owner of Shatki 11 Lombard, Inc. d/b/a Famous Liquor located at 105 E. Roosevelt Road, for the January 1, - June 30, 2022 license term.

Attached is an ordinance amending Title XI, Chapter 112, Section 112.13(A) decreasing and increasing the Class “F” liquor license category by one relative to the new ownership of Shatki 11 Lombard, Inc. d/b/a Famous Liquor, located at 105 E. Roosevelt Road.

ORDINANCE _____

**AN ORDINANCE AMENDING TITLE 11, CHAPTER 112,
SECTION 112.13 (A) OF THE LOMBARD VILLAGE CODE IN
REGARD TO ALCOHOLIC BEVERAGES**

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE
VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS** as follows:

Section 1: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class “F” liquor license category, contained therein, to read as follows:

Class “F” – 4

This decrease in the number of Class “F” liquor licenses reflects the ceasing of business by Shatki 11 Lombard, Inc. d/b/a Famous Liquor, and the termination of the Class “F” liquor license issued to Shatki 11 Lombard, Inc. in relation thereto.

Section 2: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class “F” liquor license category, contained therein, to read as follows:

Class “F” – 5

This increase in the number of Class “F” liquor licenses reflects the issuance of a Class “F” liquor license to Shatki 11 Lombard, Inc. who will be operating the business, under its new owner, commonly known as Famous Liquor, located at 105 E. Roosevelt Road, Lombard, IL.

Section 3: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
