

### ORDINANCE NO. 5414

AN ORDINANCE OF THE VILLAGE OF LOMBARD, DUPAGE COUNTY, ILLINOIS, PROVIDING FOR THE SUBMISSION OF THE QUESTION OF WHETHER THE VILLAGE OF LOMBARD SHALL ISSUE GENERAL OBLIGATION BONDS IN AN AMOUNT NOT TO EXCEED TWENTY-THREE MILLION FIVE HUNDRED THOUSAND (\$23,500,000) DOLLARS FOR THE PURPOSE OF CONSTRUCTING A NEW LIBRARY BUILDING AND FOR THE PURCHASE OF NECESSARY EQUIPMENT THEREFOR TO THE ELECTORS OF THE VILLAGE AT THE GENERAL PRIMARY ELECTION TO BE HELD ON THE 16<sup>TH</sup> DAY OF MARCH, 2004

WHEREAS, pursuant to 75 ILCS 5/5-1, the Board of Library Trustees of the Helen M. Plum Memorial Library has prepared a plan and estimate of cost for the construction of a new library building and for the purchase of necessary equipment therefor; and

WHEREAS, pursuant to 75 ILCS 5/5-1, the Board of Library Trustees of the Helen M. Plum Memorial Library has determined how much cash on hand is available for said construction, how much of the construction cost will need to be funded by a bond issue and what the term of said bond issue would be; and

WHEREAS, pursuant to 75 ILCS 5/5-1, the Board of Library Trustees of the Helen M. Plum Memorial Library has made a record of its proceedings relative to the foregoing in the form of a Resolution adopted by said Board of Library Trustees, and has forwarded same to the President and Board of Trustees of the Village for their consideration and approval; and

WHEREAS, the President and Board of Trustees hereby approve of the Board of Library Trustees' plan and estimate as submitted;

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

SECTION 1: That pursuant to 75 ILCS 5/5-2, the President and Board of Trustees of the Village, by adoption of this Ordinance, indicate their approval of the plan and estimate submitted by the Board of Library Trustees of the Helen M. Plum Memorial Library and hereby agree to provide for the issuance of the necessary Village bonds to finance the cost of the construction of

the new library building and the purchasing of necessary equipment therefor, subject to the approval of the bond referendum provided for by this Ordinance pursuant to 75 ILCS 5/5-7.

SECTION 2: That the following proposition shall be submitted to the voters of the Village of Lombard (the "Village") at the general primary election to be held on Tuesday, the 16th day of March, 2004 (the "Election"):

"Shall the Village of Lombard, on behalf of the Helen M. Plum Memorial Library Board of Library Trustees, issue general obligation bonds in an amount not to exceed Twenty-Three Million Five Hundred Thousand (\$23,500,000) Dollars for the purpose of constructing a new library building and for the purchase of necessary equipment therefor?"

SECTION 3: That the Election shall be held in the voting precincts and at the polling places established for the Village by the Board of Election Commissioners of DuPage County, Illinois (the "Election Commissioners").

SECTION 4: That notice of said Election shall be given in accordance with The Election Code of the State of Illinois, 10 ILCS 5/1-1 et seq., (the "Code") by the Executive Director of the Election Commissioners by publishing Notice thereof once in one or more newspapers published in the Village of Lombard, and if none, then published once in a local, community newspaper, having general circulation in the Village of Lombard, and also once in a newspaper published in DuPage County, the date of such publication of such notice to be at least ten (10) days prior to the date of said Election, but not more than thirty (30) days prior to the date of said Election, all in accordance with Article 12 of the Code.

SECTION 5: That where the an electronic, mechanical, or electric voting system ("Electronic Voting System") is used at the Election, a true and legible copy of the specimen ballot label to be used at the Election shall be published and made available for public distribution and shall be supplied to the judges of said Election for posting in the polling places on the date of the Election, as required by §24A-18 of the Code.

SECTION 6: That it is hereby found and determined that the Lombard Spectator, is a local community newspaper having general circulation in the Village as required by §§ 12-4 and 12-5 of the Code.

<u>SECTION 7</u>: That said Notice shall include the following:

Plum Memorial Library Board of Library Trustees, issue general obligation bonds in an amount not to exceed Twenty-Three Million Five Hundred Thousand (\$23,500,000) Dollars for the purpose of constructing a new library building and for the purchase of necessary equipment therefor?"
