Alcoholic Beverages
Voluntary Non-Renewal of Liquor License**

In accordance with Village Code, liquor licenses are renewed on a semi-annual basis. Village staff completed the renewal process for the July 1 through December 31, 2022 licensing term. The Simple Greek LLC d/b/a The Simple Greek located at 789 E. Butterfield Road, notified the Village staff that the licensee will voluntarily not renew their liquor license for the upcoming licensing term.

Attached is an ordinance decreasing the number of entries in the "C" liquor license classification by one, effective July 1, 2022, to account for their voluntary non-renewal.

Staff is requesting a waiver of first reading in order bring the number of entries in each liquor classification current.

ORDINANCE

**AN ORDINANCE AMENDING TITLE XI, CHAPTER 112,
SECTION 112.13(A) OF THE LOMBARD VILLAGE CODE TO REDUCE THE
NUMBER OF AVAILABLE LIQUOR LICENSES IN THE CLASS
“C” LIQUOR LICENSE CATEGORY**

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF
THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS** as follows:

SECTION 1: That, effective July 1, 2022, Title XI, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by decreasing the entries relative to the Class “C” liquor licenses, contained therein, to read as follows:

Class “C” – 8

SECTION 2: That, effective July 1, 2022, the decrease in the number of Class “C” liquor licenses set forth in Section 1 above is a result of The Simple Greek Chicagoland, LLC d/b/a The Simple Greek, 789 E. Butterfield Road, voluntarily not renewing their liquor license for the July 1, 2022 liquor licensing term.

SECTION 3: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
