**AN ORDINANCE AMENDING TITLE 3, CHAPTER 34 OF  
THE LOMBARD VILLAGE CODE IN REGARD TO RESIDENTIAL  
DWELLING PROXIMITY REQUIREMENT FOR POLICE CHIEF**

**BE IT ORDAINED** by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

**SECTION 1:** That Title 3, Chapter 34 of the Lombard Village Code is amended by adding § 34.27 to read as follows:

**§ 34.27 RESIDENTIAL DWELLING PROXIMITY REQUIREMENT**

- (A) The Police Chief shall be required to reside within a five (5) mile radius of the intersection of Main Street and Wilson Avenue in the Village.
- (B) Any person appointed to the office of Police Chief who does not meet the requirement of this Section at the time of appointment, shall have one (1) year to come into compliance with this Section from the date of appointment. The Village Manager shall have the discretion to grant said persons additional time to come into compliance with this Section based on a showing of hardship.

**SECTION 2:** That this Ordinance shall be in full force and effect from and after its adoption, approval and publication in pamphlet form as provided by law.
