

## ORDINANCE NO. 4902

## AN ORDINANCE AMENDING TITLE 11, CHAPTER 110, SECTION 110.08(E) OF THE LOMBARD VILLAGE CODE IN REGARD TO THE NUMBER OF AUTHORIZED BILLIARD/POOL HALL LICENSES

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DUPAGE COUNTY, ILLINOIS, as follows:

Section 1: That Title 11, Chapter 110, Section 110.08(E), of the Lombard Village Code is hereby amended to read as follows:

(E)There shall be not more than one (1) billiard/pool hall license issued in the Village of Lombard.

Section 2: This Ordinance shall be in full force and effect from and after its passage and approval as provided by law.
