

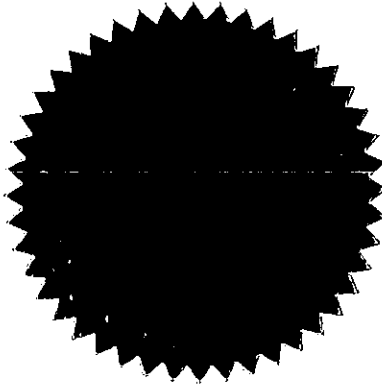



**ORDINANCE AMENDING THE LOMBARD TRAFFIC CODE**

WHEREAS, the President and Board of Trustees of the Village of Lombard have heretofore passed and approved Ordinance 1186, An Ordinance Regulating Traffic in the Village of Lombard (hereinafter the Lombard Traffic Code); and

WHEREAS, the President and Board of Trustees of the Village of Lombard find that the Lombard Traffic Code has been amended from time to time; and

WHEREAS, the Transportation and Safety Committee has reviewed the appropriate traffic studies and recommends certain changes to the Lombard Traffic Code; and

WHEREAS, the Corporate Authorities of the Village of Lombard concur in the recommendation of the Transportation and Safety Committee.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, as follows:

Section 1: That Schedule XX (b) of the Lombard Traffic Code (Ordinance 1186) entitled NO STOPPING, STANDING OR PARKING (during the hours of 8:00 a.m. to 4:00 p.m. on school days) be amended to add the following thereto:

<u>Name of Street</u>	<u>From</u>	<u>To</u>
Green Valley Dr. West east side	south curb line of Madison Street	a point 175 feet south
Green Valley Dr. West east side	385 feet north of the north curb line of Madison St.	a point 475 feet north

Section 2: That Schedule XX (d) of the Lombard Traffic Code (Ordinance 1186) entitled NO STOPPING, STANDING OR PARKING (during the hours of 7:30 a.m. to 3:00 p.m. on school days) be amended to change the first paragraph as follows:

(d) In accordance with Village of Lombard Ordinances, no stopping, standing, or parking during the hours of 7:30 a.m. to 4:00 p.m. on school days are prohibited at the following locations:

Section 3: That this Ordinance shall be in full force and effect from and after its passage, approval, publication in pamphlet form and the posting of appropriate signs as provided by law.


