AN ORDINANCE AMENDING TITLE 11, CHAPTER 112 OF THE LOMBARD VILLAGE CODE IN REGARD TO ALCOHOLIC BEVERAGES

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS as follows:

SECTION 1: That Title 11, Chapter 112, Sections 112.12 of the Lombard Village Code, regarding Liquor Classifications, Class "Z" is amended to read in its entirety as follows:

"Class "Z" – Alcoholic beverages served as an adjunct to food service at a location that also brews beer on the licenses premises. The sale of beer brewed on the licensed premises for carry-out shall be allowed; with all other package sales prohibited. (Restaurant/Brew Pub)."
