BACKGROUND/POLICY IMPLICATIONS:

In response to complaints and inquiries from commuters and in an effort to make better use of the commuter parking spaces available to residents, Staff requests that 14 additional spaces in the 101 S Main Street commuter parking lot be converted from resident-only quarterly permit parking to resident-only daily fee parking. This change would bring the number of quarterly permit spaces to 55 and the number of daily fee spaces to 30 for that lot. No other commuter parking lots would be affected by this change.

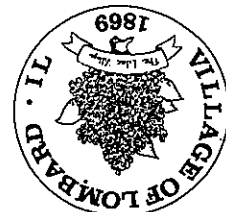

Conversion of Resident-Only Commuter Parking Spaces in the 101 S Main Street
Commuter Parking Lot

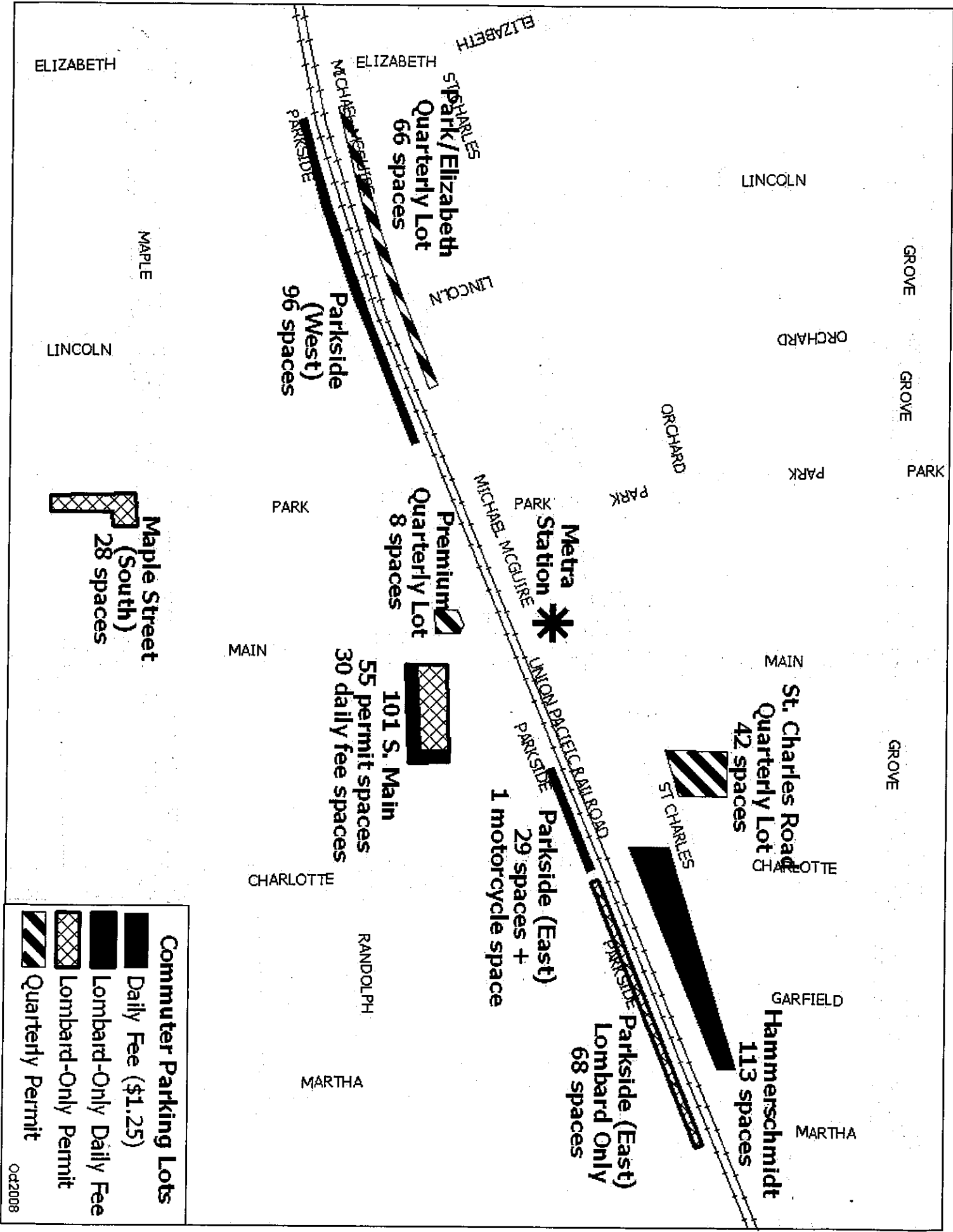
As you know, on March 6, 2008, the Village Board authorized the conversion of several of its commuter parking lots to resident-only commuter parking lots. This change became effective on May 1, 2008 with a total of 181 spaces converted. Of these 181 spaces, 165 spaces were converted from daily fee parking to resident-only quarterly permit parking, and 16 spaces remained daily fee parking, however for resident-only.

Since these changes were made in May to better accommodate Lombard residents, Staff has received numerous complaints and inquiries from commuters regarding the need for more daily parking spaces. In addition, Staff has observed that the quarterly permits, although being sold over capacity, are not filling up on a daily basis. This has lead Staff to believe that the commuters holding the quarterly permits are not using the lots consistently on a daily basis.

In an effort to make better use of the parking spaces available and, in addition, generate more revenue for the Village, Staff recommends that 14 additional spaces in the 101 S Main Street commuter parking lot be converted from resident-only quarterly permit parking to resident-only daily fee parking. This change in the 101 S Main Street commuter parking lot would bring the number of quarterly permit spaces to 55 and the number of daily fee spaces to 30 for that lot. No other commuter parking lots would be affected by this change. Please see the attached map.

Please note that Staff from various departments including Finance, Community Development, Police, and Public Works has been involved in making this recommendation to the Village Board as we work in coordination to better serve our residents.

Attached is an ordinance authorizing the conversion of an additional 14 spaces in the 101 S Main Street lot from resident-only quarterly parking spaces to resident-only daily fee spaces. I am requesting that this item be placed on the Village Board agenda for Thursday, November 6. Please let me know if you have any questions.

ORDINANCE AMENDING THE LOMBARD TRAFFIC CODE

ORDINANCE NO. _____

WHEREAS, the President and Board of Trustees of the Village of Lombard have heretofore passed and approved Ordinance 6172, An Ordinance regulating commuter parking at the 101 S. Main Street parking lot; and

WHEREAS, the President and Board of Trustees of the Village of Lombard find that the Lombard Traffic Code has been amended from time to time; and

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, as follows:

Section 1: That Schedule XII (d) of the Lombard Traffic Code entitled LOMBARD RESIDENT DAILY FEE PARKING ZONES is hereby amended to read in its entirety as follows:

In accordance with Section 10-13-14 and Section 10-13-18, Lombard resident daily fee parking zones are described below. The payment of fees in the coin box shall be required between the hours of 5:00 a.m. and 3:00 p.m., except Saturdays, Sundays and holidays; provided, however, that for purposes of this Section the term holiday shall include only the following days: the first day of January, the fourth Monday of May, the fourth day of July, the first Monday in September, the fourth Thursday in November and the twenty-fifth day of December.

101 S. Main Street Lot: Six (6) spaces along the easternmost edge of the parking lot and ten (10) spaces twenty-four (24) spaces along the northernmost southernmost edge of the parking lot.

Section 4: That this Ordinance shall be in full force and effect from and after its passage, approval, publication in pamphlet form and the posting of appropriate signs are provided by law.
