**AN ORDINANCE AMENDING ORDINANCE NO. 7647,  
ADOPTED APRIL 4, 2019, ENTITLED,  
“AN ORDINANCE AMENDING TITLE XI, CHAPTER 110, SECTION 110.11;  
TITLE XI, CHAPTER 112; AND TITLE XI, CHAPTER 115  
OF THE LOMBARD VILLAGE CODE IN REGARD TO VIDEO GAMING  
AND LIQUOR LICENSES FOR ESTABLISHMENTS WITH VIDEO GAMING”,  
AS AMENDED BY ORDINANCE NO. 7763, ADOPTED DECEMBER 5, 2019,

**BE IT ORDAINED** by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

**SECTION 1:** That Sections 14, 15 and 16 of Ordinance No. 7647, adopted April 4, 2019, as amended by Ordinance No. 7763, adopted December 5, 2019, are hereby repealed.

**SECTION 2:** That all other provisions of Ordinance No. 7647, adopted April 4, 2019, as amended by Ordinance No. 7763, adopted December 5, 2019, and the Lombard Village Code amendments made thereby, not amended hereby, shall remain in full force and effect.

**SECTION 3:** That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, as provided by law.


