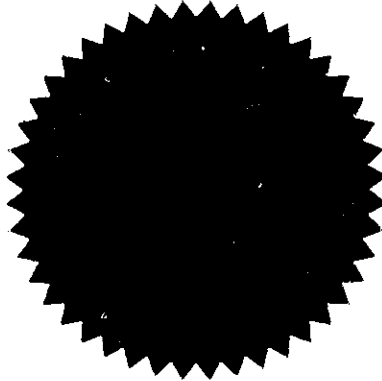

AMENDING TITLE 7, CHAPTER 70 OF
THE LOMBARD VILLAGE CODE IN REGARD TO
MOTOR VEHICLE LICENSING

ORDINANCE 4741

AN ORDINANCE AMENDING TITLE 7, CHAPTER 70, OF THE LOMBARD VILLAGE CODE IN REGARD TO MOTOR VEHICLE LICENSING

BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard,

DuPage County, Illinois, as follows:

SECTION 1: That Title 7, Chapter 70, Section 70.02 (A) of the Lombard Village Code is

amended by adding the following between the words, "Village" and "to" in the seventh line thereof:

"or, pursuant to 625 ILCS 5/2-121, is licensed by the place where the motor vehicle has its situs or base if other than the Village,"

SECTION 2: That Title 7, Chapter 70, Section 70.02 of the Lombard Village Code is

amended by adding a new subsection (D) thereto which shall read in its entirety as follows:

"(D) Where a motor vehicle is, pursuant to the records of the Illinois Secretary of State's Office, shown to be registered to an address within the Village, said registration shall give rise to a presumption that said motor vehicle has its situs or base in the Village."

SECTION 3: That Title 7, Chapter 70, section 70.03 of the Lombard Village Code is

amended by adding the following to the end thereof:

"Effective with the 2000-2001 license year, applications and notices relative to the license required by this Chapter shall contain a statement relative to the requirements of Section 70.02 of this Code and a statement relative to the requirements set forth in Section 70.07 of this Code."

SECTION 4: That this Ordinance shall be in full force and effect from and after its passage,

approval and publication in pamphlet form as provided by law.






