BACKGROUND/POLICY IMPLICATIONS:

080589: Lincoln Avenue North of St. Charles Road - No Parking Zone
On October 6, 2008, the Transportation and Safety Committee voted to recommend adding No Parking Zones on the east and west sides of Lincoln Avenue, just north of St. Charles Road, to improve driver sight distances for vehicles exiting the residential parking lots.

080590: Garfield Street, Roosevelt Road to 13th Street - No Parking Zone
On October 6, 2008, the Transportation and Safety Committee voted to recommend relocation of a No Parking Zone from the west side of Garfield Street between Roosevelt Road and 13th Street to the east side.

080591: Grove Street, Park Avenue to Main - No Parking Zone
On October 6, 2008, the Transportation and Safety Committee voted to recommend the expansion a No Parking Zone during Cruise Nights on Grove Street to preserve two-way traffic during the event and ease congestion at the Grove Street and Park Avenue intersection.

080592: Splash Park Parking Lot - Parking Hours
On October 6, 2008, the Transportation and Safety Committee voted to recommend the extension of parking time limits from two (2) to three (3) hours at the Splash Park parking lot, located on the southwest corner of St. Charles Road and Lincoln Street.

In accordance with Section 10-13-6 and when signs are erected giving notice thereof, no person shall, at any time, park a vehicle upon any of the following streets or parts of streets:

080590: Garfield Street, Roosevelt Road to 13th Street - No Parking Zone
 On October 6, 2008, the Transportation and Safety Committee discussed eliminating conflicting information between Schedule VII and Schedule X of the Traffic Code. Specifically, parking is both prohibited and permitted on the west side of Garfield Street between Roosevelt Road and 13th Street. The Committee voted to recommend movement of the No Parking Zone to the east side of Garfield Street as follows, which requires an ordinance to the Traffic Code.

080589: Lincoln Avenue North of St. Charles Road - No Parking Zone
 On October 6, 2008, the Transportation and Safety Committee discussed adding No Parking Zones on Lincoln Avenue to improve driver sight distances for vehicles exiting the residential parking lots. The Committee voted to recommend adding No Parking Zones on Lincoln Avenue, just north of St. Charles Road, as follows, which requires an ordinance to the Traffic Code.

080591: Grove Street, Park Avenue to Main – No Parking Zone

On October 6, 2008, the Transportation and Safety Committee discussed traffic congestion at the intersection of Park and Grove Streets during Cruise Night activities. In order to maintain two-way traffic on Grove Street during Cruise Nights, the Committee voted to recommend extending the existing No Parking Zone during Cruise Nights on the north side of Grove Street between Park and Lincoln Avenues, to between Main Street and Lincoln Avenue as follows, which requires an ordinance to the Traffic Code.

(1) In accordance with Section 10-13-3 and when signs are erected giving notice thereof, no person shall, at any time, park a vehicle between the hours of 5:00 p.m. – 10:00 p.m. during Cruise Nights upon any of the following streets or parts of streets:

080592: Splash Park Parking Lot – Parking Hours

On October 6, 2008, the Transportation and Safety Committee discussed existing parking restrictions at the Splash Park parking lot, located on the southwest corner of St. Charles Road and Lincoln Street. The

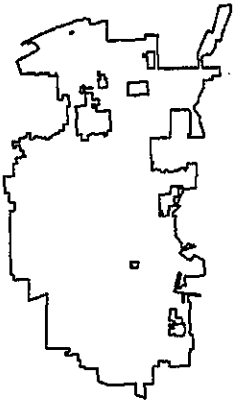
Committee voted to recommend extending the parking restriction from two (2) to three (3) hours as follows, to allow for patrons to utilize the facilities and the local shops/cuisine in the area with less time constraints, which requires an ordinance to the Traffic Code.

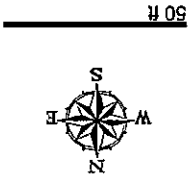

Lincoln Avenue - Proposed NO PARKING ZONE

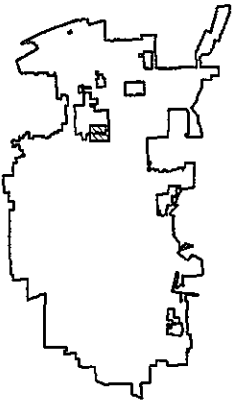
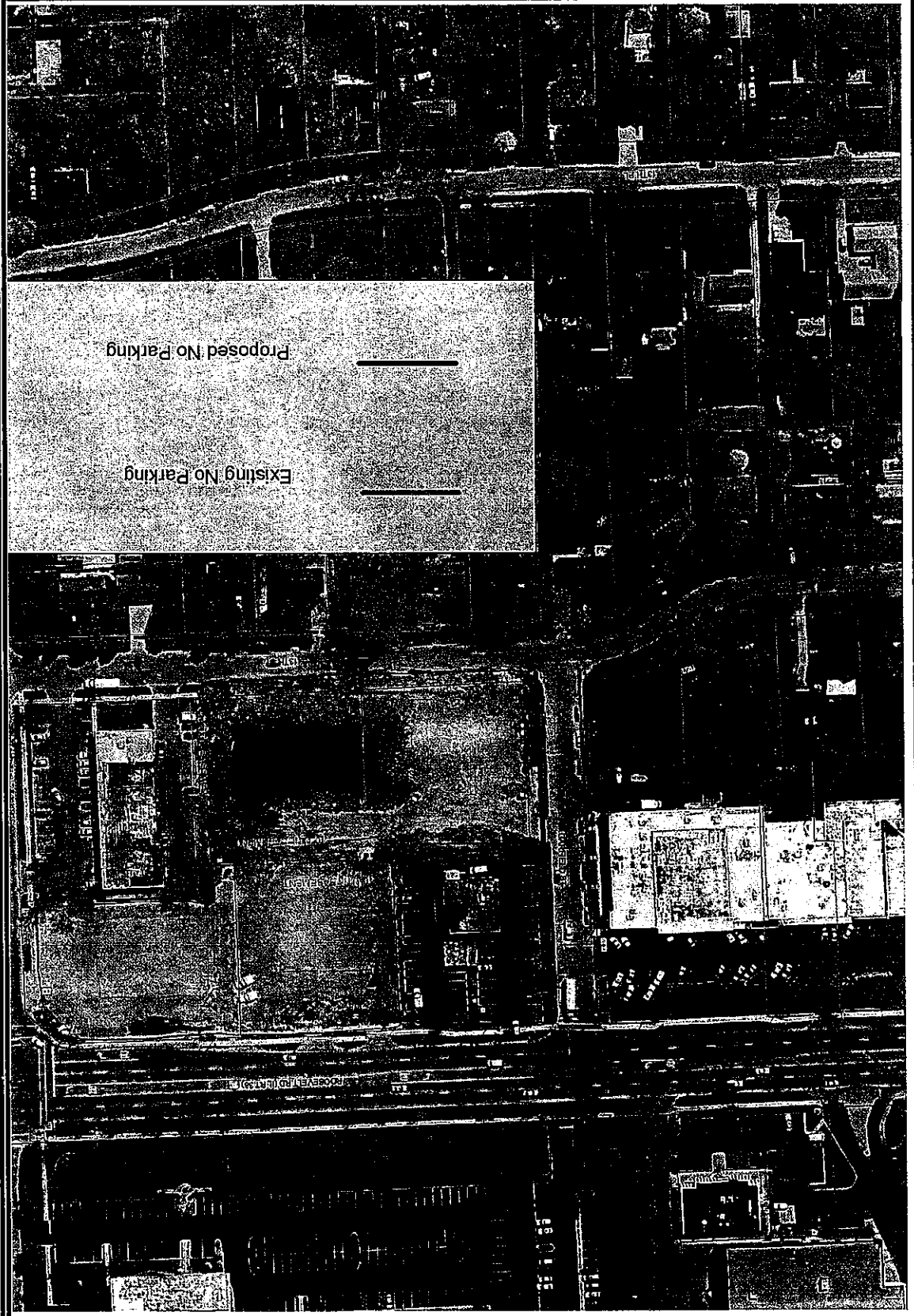

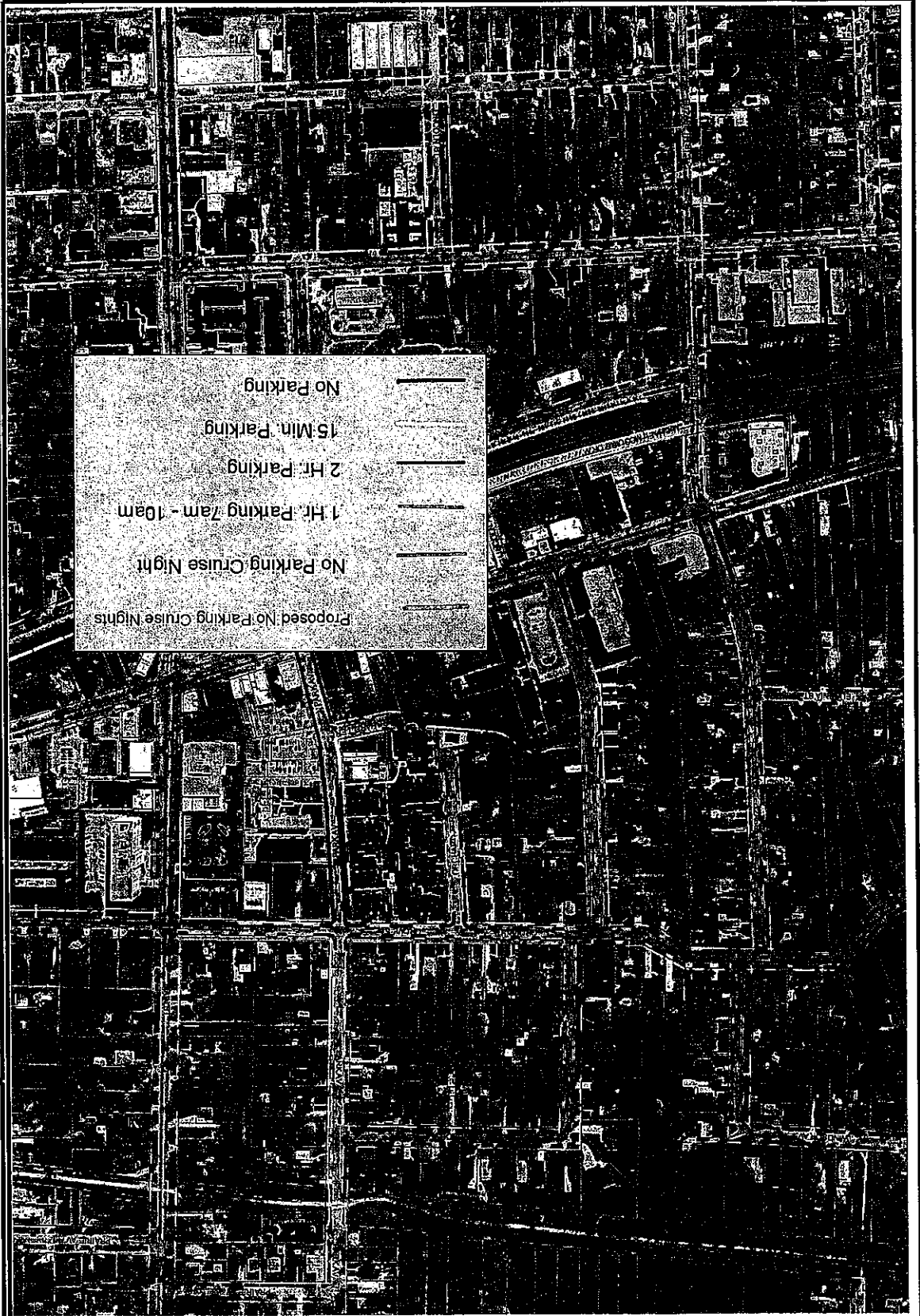

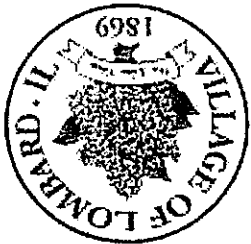
Grove and Park - Parking Status

ORDINANCE AMENDING THE LOMBARD TRAFFIC CODE

WHEREAS, the President and Board of Trustees of the Village of Lombard have heretofore passed and approved Ordinance 1186, An Ordinance Regulating Traffic in the Village of Lombard (hereinafter the Lombard Traffic Code); and

WHEREAS, the President and Board of Trustees of the Village of Lombard find that the Lombard Traffic Code has been amended from time to time; and

WHEREAS, the Transportation and Safety Committee has reviewed the appropriate traffic studies and recommends certain changes to the Lombard Traffic Code; and

WHEREAS, the Corporate Authorities of the Village of Lombard concur in the recommendation of the Transportation and Safety Committee.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, as follows:

Section 1: That Schedule VII of the Lombard Traffic Code (Ordinance 1186) entitled PARKING PROHIBITED AT ALL TIMES ON CERTAIN STREETS be amended to add the following thereto:

Lincoln Ave. West side	A point 235 feet north of the north curb line of St. Charles Rd.	A point 325 feet north of the north curb line of St. Charles Rd.
Lincoln Ave. East side	North curb line of St. Charles Rd.	A point 126 feet north
Garfield St. East side	Roosevelt Road	13 th Street

Section 2: That Schedule VII of the Lombard Traffic Code (Ordinance 1186) entitled PARKING PROHIBITED AT ALL TIMES ON CERTAIN STREETS be amended to delete the following therefrom:
