ORDINANCE _____

**AN ORDINANCE AMENDING TITLE 11, CHAPTER 112,
SECTION 112.13 OF THE LOMBARD VILLAGE CODE IN
REGARD TO ALCOHOLIC BEVERAGES**

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES
OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS** as follows:

Section 1: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the "Class C" liquor license, contained therein, to read as follows:

Class "C" - 8

This decrease in Class "C" liquor licenses reflects the termination of Gong Khlang Inc. d/b/a/ Thai Sawasdee Restaurant and the termination of the Class "C" liquor license issued to Gong Khlang Inc. in relation thereto.

Section 2: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "C" liquor license, contained therein, to read as follows:

Class "C" - 9

This increase in Class "C" liquor licenses reflects the issuance of a Class "C" liquor license to Kaow Sarm Kaow, Inc. who is operating the business commonly known as Thai Sawasdee Restaurant located at 845 E. Roosevelt Road, Lombard, IL.

Section 3: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
