

AN ORDINANCE AMENDING TITLE 7, CHAPTER 70, SECTION 70.99 OF THE LOMBARD VILLAGE CODE IN REGARD TO MOTOR VEHICLE LICENSING

BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

SECTION 1: That Title 7, Chapter 70, Section 70.99 of the Lombard Village Code is amended to read in its entirety as follows:

"§70.99 PENALTY.

Any person who shall violate any provision of this Chapter 70 shall, upon conviction thereof, be subject to a fine of not less than the greater of fifty and no/100 dollars (\$50.00) or the total license and late fees then due the Village (but not more than seven hundred fifty and no/100 dollars (\$750.00) per offense), nor more than seven hundred fifty and no/100 dollars (\$750.00) for each offense. The Police Department shall not commence prosecution proceedings relative to a complaint against any violator who appears at the Lombard Municipal Building and pays the sum of fifty and no/100 dollars (\$50.00) within 72 hours (which shall not include weekends or holidays), or pays seventy-five and no/100 dollars (\$75.00) after 72 hours, but prior to the filing of a complaint with the Clerk of the Court of the Eighteenth Judicial Circuit, and who, in both cases, shows proof of the purchase of the license in relation to which the complaint relates."

SECTION 2: That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
