**SUBJECT: Request for a Class "I-VG" Liquor License – Moose Lodge #2350
328 W. Roosevelt Road**

As you are aware the Village of Lombard Board of Trustees on April 4, 2019 approved video gaming for certain liquor license classifications by Ordinance 7647.

Lombard Lodge #2350, Loyal Order of Moose d/b/a Lombard Moose Lodge #2350 located at 328 W. Roosevelt Road currently holds a Class "I" liquor license which allows alcoholic beverages served for consumption on the premises of a not-for-profit entity.

Staff is currently in the process of renewing liquor licenses for the July 1 through December 31, 2019 liquor licensing term. Lombard Lodge #2350, Loyal Order of Moose d/b/a Lombard Moose Lodge #2350 has decided to voluntarily not renew their Class "I" license for the upcoming liquor licensing term and Lombard Lodge #2350, Loyal Order of Moose d/b/a Lombard Moose Lodge #2350 has applied for a new Class "I-VG" liquor license.

Attached is an ordinance amending Title XI, Chapter 112, Section 112.13(A) decreasing the number of entries in the Class "I" liquor license category by one and increasing the number of entries in the Class "I-VG" license category by one, effective July 1, 2019.

Staff is requesting a waiver of first reading due to the timing of the new liquor licensing term.

ORDINANCE _____

**AN ORDINANCE AMENDING TITLE XI, CHAPTER 112,
SECTION 112.13(A) OF THE LOMBARD VILLAGE CODE IN
REGARD TO ALCOHOLIC BEVERAGES**

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES
OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS as follows:**

Section 1: That, effective July 1, 2019, Title XI, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the entry relative to the Class "I" liquor license, contained therein, to read as follows:

Class "I" - 2

This decrease in the number of Class "I" liquor licenses reflects the voluntary non-renewal of Lombard Lodge #2350, Loyal Order of Moose d/b/a Lombard Moose Lodge #2350 located at 328 W. Roosevelt Rd. for the July 1 through December 31, 2019 licensing term and the termination of the Class "I" liquor license issued to Lombard Lodge #2350, Loyal Order of Moose d/b/a Lombard Moose Lodge #2350 in relation thereto.

Section 2: That, effective July 1, 2019, Title XI, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the entry relative to the Class "I-VG" liquor license, contained therein, to read as follows:

Class "I-VG" - 1

This increase in the number of Class "I-VG" liquor licenses reflects the issuance of a new Class "I-VG" liquor license to Lombard Lodge #2350, Loyal Order of Moose d/b/a Lombard Moose Lodge #2350 located at 328 W. Roosevelt Rd, Lombard, IL.

Section 3: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
