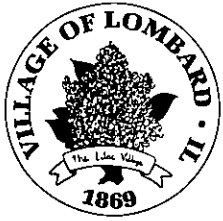

ORDINANCE _____

**AN ORDINANCE AMENDING TITLE 11, CHAPTER 121,
SECTION 121.03 OF THE LOMBARD VILLAGE CODE IN
REGARD TO PUBLIC PASSENGER LICENSES**

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES
OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS** as follows:

Section 1: That Title 11, Chapter 121, Section 121.03 (A) (2) of the Lombard Village Code is amended to read as follows:

(2) Number

There shall be nine (9) Business Licenses issued by the Village. No additional Business Licenses shall be issued unless approved by the Board of Trustees.

Section 2: That the change in the number of Public Passenger Licenses set forth in Section 1 above, is a result of granting a business license to Expert Fence Erectors, Inc. d/b/a Holiday Taxi & Limo Service located at 213 W. Main Street, Plainfield, IL.

Section 3: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.

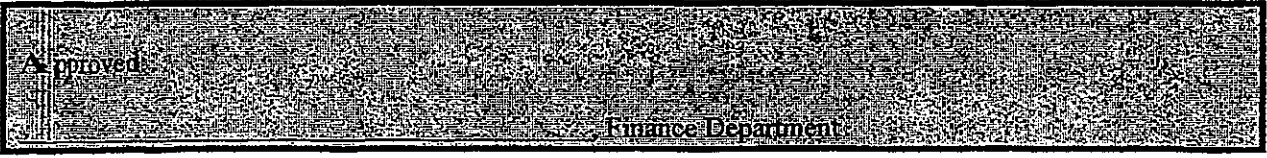

24/7

- 1) Driver's shall keep their vehicle clean and presentable.
- 2) Driver shall be dressed in clean and neat apparel.
- 3) Driver's shall be personally well groomed and presentable.
- 3) Smoking shall not be allowed in their vehicle.
- 4) Driver's shall report for work at their designated time.
- 5) Driver's shall be courteous at all times to their passengers.
- 6) Driver's shall have a GPS in the vehicle at all times.
- 7) Driver's shall check \vehicle fluid levels daily at the start of their shift.
