Subject: Motion to Waive Bids and Approve Purchasing Clothing and Uniform Items from Galls LLC and Ray O'Herron for the Police Department in an amount not-to exceed \$85,750

The Police Department purchases clothing and uniforms from both Galls LLC and Ray O'Herron, Inc. and are satisfied with the service, pricing, and convenience.

Ray O'Herron has a brick-and-mortar store located in Downers Grove, which allows the Village to send employees directly to the store to be measured and outfitted with their uniforms and equipment. Police Department employees can bring items directly to the store for exchange and repair, and newly ordered items are often picked up the same day. Gall's LLC provides both online service and does have stores in Chicago.

In 2023, the Hanover Park Police Department requested quotes from four vendors on 46 commonly used items. Four vendors responded and provided quotes. The lowest price was Galls followed by Ray O'Herron, JG Uniforms and Municipal Emergency Services & Lawmen Supply. Galls had the lowest price on 24 items. Ray O'Herron was the lowest on 17 items, including several duty gear and outerwear, which are some of the most expensive uniform items issued to personnel.

Staff recommends the Village Board approve the purchase of clothing and uniforms items from both Galls LLC. and Ray O'Herron, Inc., in an amount not-to-exceed \$85,750. These funds are provided for in the FY 2024 Budget.
