## **ORDINANCE NO. 6823**

## AN ORDINANCE AMENDING TITLE 11, CHAPTER 112 OF THE LOMBARD VILLAGE CODE IN REGARD TO ALCOHOLIC BEVERAGES AND NEW CLASS "Q-I" AND "Q-II" LIQUOR LICENSE CATEGORIES

**BE IT ORDAINED** by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

**SECTION 1:** That Title 11, Chapter 112, Section 112.12(A) of the Lombard Village Code is amended by adding language thereto, relative to a new Class "Q-l" liquor license category, to read in its entirety as follows:

"Class "Q-I" – Package sales of wine only at a Farmers Market, from June 1<sup>st</sup> to September 15<sup>th</sup>, subject to the following conditions:

- (1) The sales can take place no more than once per week, for a period of no more than four (4) hours; and
- (2) Providing samples/tastings of the wine shall be allowed."

SECTION 2: That Title 11, Chapter 112, Section 112.12(A) of the Lombard Village Code is amended by adding language thereto, relative to a new Class "Q-II" liquor license category, to read in its entirety as follows:

"Class "Q-II" – Package sales of wine only at a Farmers Market, from June 1<sup>st</sup> to September 15<sup>th</sup>, by a liquor licensee that currently holds a Class "L" liquor license, subject to the following conditions:

- (1) The sales can take place no more than once per week, for a period of no more than four (4) hours; and
- (2) Providing samples/tastings of the wine shall be allowed."

SECTION 3: That Title 11, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by adding language thereto, relative to new Class "Q-I" and "Q-II" liquor license categories, to read in its entirety as follows:

"Class "Q-I" - 0 Class "Q-II" - 0"

SECTION 4: That Title 11, Chapter 112, Section 112.14(A) of the Lombard Village Code is amended by adding language thereto, relative to new Class "Q-I" and "Q-II" liquor license categories, to read in its entirety as follows:

"Class "Q-I" - \$250 per Farmers Market season (June 1<sup>st</sup> to September 15<sup>th</sup>) Class "Q-II" - \$250 per Farmers Market season (June 1<sup>st</sup> to September 15<sup>th</sup>)"

<u>SECTION 5:</u> That Title 11, Chapter 112, Section 112.14(A) of the Lombard Village Code is amended as follows:

- A. That the parenthetical phrase after the entry relative to the Class "J" liquor license, as contained therein, is revised by changing the reference to "except Class "P," as noted below," to read, "except Classes "P," "Q-I" and "Q-II," as noted below."
- B. That the parenthetical phrase after the Application Fee, as contained therein, is revised to read in its entirety as follows: "(Except for Class "J," Class "P" and Class "Q-II," which shall have no Application Fee, and Class "Q-I," which shall have a \$100 Application Fee)."

SECTION 6: That Title 11, Chapter 112, Section 112.16 of the Lombard Village Code is amended by revising the parenthetical phrase, as contained therein, to read in its entirety as follows: "(with the exception of Classes "J," "P," "Q-I" and "Q-II")."

**SECTION 7:** That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
