## **ORDINANCE NO. 6914**

AN ORDINANCE AMENDING TITLE 11, CHAPTER 112, SECTION 112.18(B)
OF THE LOMBARD VILLAGE CODE IN REGARD TO
ALCOHOLIC BEVERAGES, PROVIDING FOR THE SALE AND CONSUMPTION
OF ALCOHOL IN CONNECTION WITH A
TEMPORARY EVENT WITHIN THE PARKSIDE AVENUE PUBLIC RIGHT OF WAY

**BE IT ORDAINED** by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

**SECTION 1:** That Title 11, Chapter 112, Section 112.18(B) of the Lombard Village Code is hereby amended by adding new subsection (6) thereto, effective upon the adoption of this Ordinance through 7:00 p.m. on Saturday, June 14, 2014, which shall read in its entirety, as follows:

"(6) That in association with a Craft Beer Festival to be sponsored by the Glenbard East Booster Club, a not-for-profit corporation (# 67303857), the Glenbard East Booster Club shall be eligible for a Class "J" liquor license for the sole purpose of selling beer for consumption, on Saturday, June 14, 2014, from 12:00 p.m. (noon) to 6:00 p.m., in a designated and secured area, approved by the Village pursuant to the issuance of a temporary event permit under Chapter 110 of the Village Code. The liquor license to be issued under this subsection (6) may be issued by the Local Liquor Commissioner upon proper application to the Village, and satisfaction of all applicable requirements and conditions by the licensee. No liquor license shall be issued under this subsection (6) until such time as the licensee obtains the necessary temporary event permit under Chapter 110 of the Village Code, and complies with all requirements and conditions thereof, including, without limitation, the insurance, bond and indemnification requirements of Chapter 110 for temporary events."

**SECTION 2:** That, effective at 7:00 p.m. on Saturday, June 14, 2014, Title 11, Chapter 112, Section 112.18(B)(6) of the Lombard Village Code, as set forth in Section 1 above, is hereby repealed, without need for any further action by the President and Board of Trustees.

**SECTION 3:** That this Ordinance shall be in full force and effect from and after its passage and approval as provided by law.
