

## AN ORDINANCE AMENDING ORDINANCE NO. 4407, ADOPTED JANUARY 22, 1998, IN REGARD TO THE PAVING AND IMPROVING OF BREWSTER AVENUE, EDSON STREET, MAPLE STREET, VANCE STREET AND WILLOW STREET (SPECIAL ASSESSMENT 209)

BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:
