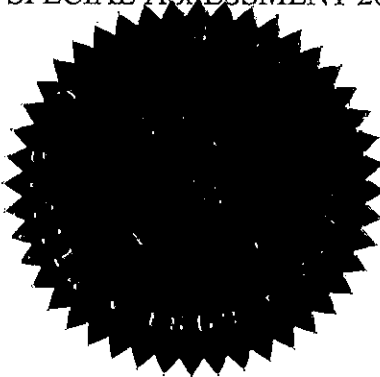

ORDINANCE NO. 4489

**AN ORDINANCE AMENDING ORDINANCE NO. 4407, ADOPTED JANUARY 22, 1998,  
IN REGARD TO THE PAVING AND IMPROVING OF BREWSTER AVENUE, EDSON  
STREET, MAPLE STREET, VANCE STREET AND WILLOW STREET  
(SPECIAL ASSESSMENT 209)**

BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard,  
DuPage County, Illinois, as follows:

Section 1: That in light of the fact that the Village of Lombard was able to sell Special  
Assessment Bonds to finance this improvement at an interest rate of 5.0 %, Section 6 of  
Ordinance No. 4407, adopted January 22, 1998, is amended to read in its entirety as follows:

"SECTION 6: The aggregate amount herein order to be assessed and each individual  
assessment shall be divided into fifteen (15) installments which shall bear interest at  
the rate of 5.0 % per annum until paid, all in the manner and in accordance with  
the provisions of the aforesaid Act 5, Article 9, Division 2, of Chapter 65 of the  
Illinois Compiled Statutes, as amended by the Special Assessment Supplemental Bond  
and Procedures Act (Public Act 90-480), which the Village hereby elects to be  
applicable to this Special Assessment."

Section 2: That all other provisions of Ordinance No. 4407, adopted January 22, 1998,  
remain in full force and effect.

Section 3: That this Ordinance shall be in full force and effect from and after its passage,  
approval and publication in pamphlet form as provided by law.



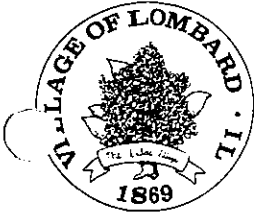


