

ORDINANCE NO. 4764

AN ORDINANCE AMENDING TITLE 9, CHAPTER 98 OF THE LOMBARD VILLAGE CODE IN REGARD TO THE HOTEL OPERATOR'S OCCUPATION TAX

BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

SECTION 1: That Title 9, Chapter 98 of the Lombard Village Code is amended by adding a new Section 98.63 thereto which shall read in its entirety as follows:

"§98.63 Maintaining Books and Records. Every taxpayer required by Section 98.61 to pay the tax imposed by Section 98.60 to the Village's Finance Department shall keep accurate books and records of its business activity, including original source documents and books of entry denoting the transactions that gave rise, or may have given rise, to any tax liability under Section 98.60. All such books and records shall be kept in the English language and, at all times during business hours of the day, shall be subject to and available for inspection and auditing by the Village's Finance Department, or its authorized agent."

SECTION 2: That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
