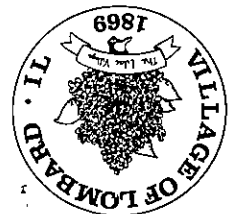

Subject: FY09 State Bid Vehicle Purchase

Included in the FY 2009 budget are the replacements for four marked squad cars. State bid for this type of vehicle has been awarded to Morrow Brothers Ford (contract # 4014904) of Greenfield, (IL). The cost of each unit is \$21,402 or \$85,608 for all four. Budgeted amount for this purchase is \$20,300 each or \$81,200 for all four. The base price of this vehicle went up about \$1,000 from last year making this purchase \$4,408 over budget.

Since there is not a lower priced suitable replacement for this vehicle I request the B.O.T. waive bid and award a contract to Morrow Brothers Ford of Greenfield (IL) in the amount of \$85,608 for four new Ford Crown Victoria Squad cars.
