BACKGROUND/POLICY IMPLICATIONS:

080207: Dist. 4: North Garfield Street No Parking Zone
On August 4, 2008, the Transportation and Safety Committee voted to recommend modifying the No Parking Zones on North Garfield Street to a less confusing configuration.

080265: Dist. 3: Intersection of Stewart Avenue and 17th Street No Parking Zone
On August 4, 2008, the Transportation and Safety Committee voted to recommend placing No Parking Zones on the northwest and southeast sides of Stewart Avenue and 17th Street to insure a safe vehicle line-of-sight at the intersection.

080463: Dist. 6: Elimination of No Parking Zone on Harding Road
On August 4, 2008, the Transportation and Safety Committee voted to recommend eliminating the No Parking Zone on the north side of Harding Road between Main and Charlotte Streets due to an increase in off-street parking availability in the area; thereby, eliminating on-street parking conflicts with area residents.

Subject: Transportation and Safety Committee Recommendations

080207: North Garfield Street No Parking Zone

On August 4, 2008, the Transportation and Safety Committee discussed modifying the existing No Parking Zones on North Garfield Street. The modifications were recommended by staff to clarify No Parking Zone locations, which are confusing as currently arranged. The businesses on North Garfield Street were provided a written survey in May, 2008, resulting in an overwhelming indifference (11% for the change, 11% against the change, 88% did not respond) to the proposed changes.

The Committee voted to recommend modifying the No Parking Zones on North Garfield Street as follows, which requires an ordinance to the Traffic Code.

080265: Intersection of Stewart Avenue and 17th Street No Parking Zone

On August 4, 2008, the Transportation and Safety Committee discussed instituting No Parking Zones along the northwest and southeast curves at the intersection of Stewart Avenue and 17th Street, due to a resident concern of parked vehicles at the subject location. Though no vehicles were parked at the subject location during staff's site inspection, it was evident a parked vehicle would block the line-of-sight for drivers traveling north or west. To be consistent with Section 155.207 of the Lombard Zoning Ordinance (line-of-sight), the Committee voted to recommend placement of No Parking Zones as follows, which requires an ordinance to the Traffic Code.

080463: Elimination of No Parking Zone on Harding Road

On August 4, 2008, the Transportation and Safety Committee discussed eliminating No Parking Zone on the north side of Harding Road between Main and Charlotte Streets. Public Works staff investigated the resident request and learned the Transportation and Safety Committee recommended and Village Board approved the placement of this No Parking Zone (Ordinance #4957) in 2001. It is staff's understanding this Ordinance was approved to eliminate an on-street parking conflict between residents and a medical facility with inadequate parking located on the southeast corner of Harding Road and Main Street. Several years ago, the medical facility relocated and a sleep center has been constructed in its' place. Adequate off-street parking is now provided for this center, yet the No Parking Zone restriction on Harding Road remains.

Additional investigation by staff found that the No Parking Zone on Harding Road was not affiliated with the Glenbard East High School Parking restrictions. Therefore, the Committee voted to recommend eliminating the No Parking Zone on the Harding Street as follows, which requires an ordinance to the Traffic Code.

ORDINANCE NO. _____

ORDINANCE AMENDING THE LOMBARD TRAFFIC CODE

WHEREAS, the President and Board of Trustees of the Village of Lombard have heretofore passed and approved Ordinance 1186, An Ordinance Regulating Traffic in the Village of Lombard (hereinafter the Lombard Traffic Code); and

WHEREAS, the President and Board of Trustees of the Village of Lombard find that the Lombard Traffic Code has been amended from time to time; and

WHEREAS, the Transportation and Safety Committee has reviewed the appropriate traffic studies and recommends certain changes to the Lombard Traffic Code; and

WHEREAS, the Corporate Authorities of the Village of Lombard concur in the recommendation of the Transportation and Safety Committee.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, as follows:

Section 1: That Schedule VII of the Lombard Traffic Code (Ordinance 1186)

entitled **PARKING TIME LIMITED ON CERTAIN STREETS** (customers only) be amended to **add** and read in its entirety:

(C) In accordance with Section 10-13-6 and when signs are erected giving notice thereof, no person shall, at any time, park a vehicle upon any of the following streets or parts of streets:

17 th Street North side	The western right-of-way line of 16 th Place	The intersection of Stewart Avenue
17 th Street South side	45 feet west of the western right-of-way line of 16 th Place	The intersection of Stewart Avenue
Stewart Avenue, both sides	The intersection of 17 th Street	A point 100 feet south
Garfield Street, west side	A point 440 feet north of the north curb line of Progress Road	A point 820 feet north

Section 2: That Schedule VII of the Lombard Traffic Code (Ordinance 1186)

entitled **PARKING PROHIBITED AT ALL TIMES ON CERTAIN STREETS** in accordance with Section 10-13-6 and when signs are erected giving notice thereof, no person shall, at any time, park a vehicle upon any of the following streets or parts of streets be amended to **delete** the following therefrom:

Garfield Street west side	A point 440 feet north of the north curb line of Progress Road	A point 500 feet north
Garfield Street west side	A point 740 feet north of the north curb line of Progress Road	A point 1285 feet north
Harding Road north side	East curb line of Main Street	West curb line of Charlotte Street

Section 3: That this Ordinance shall be in full force and effect from and after its passage, approval, publication in pamphlet form and the posting of appropriate signs as provided by law.
