

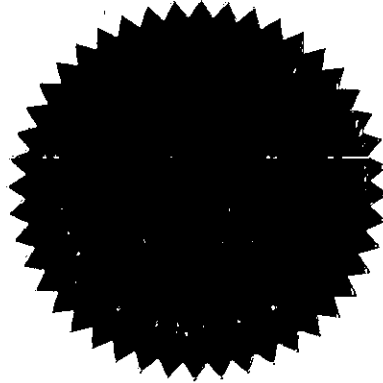



ORDINANCE NO. 5308

AN ORDINANCE AMENDING TITLE 11, CHAPTER 112 OF THE LOMBARD VILLAGE CODE IN REGARD TO LIQUOR LICENSE CLASSIFICATIONS (CONVENIENCE STORE WITH GASOLINE SALES - BEER AND WINE ONLY - VALID DUPAGE COUNTY LIQUOR LICENSE AT TIME OF ANNEXATION TO THE VILLAGE)

BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

SECTION 1: That Title 11, Chapter 112, Section 112.12(A) of the Lombard Village Code is amended by adding a description for a new the Class "ZZ" liquor license which shall read in its entirety as follows:

"Class "ZZ" - Package sales of beer and wine only, as an adjunct to a convenience store with gasoline sales which, at the time of said convenience store's annexation to the Village, had a valid DuPage County liquor license, subject to the following conditions:

1. The beer and wine sales area shall be segregated from the sales area for general merchandise; and
2. Not more than twenty percent (20%) of the floor area of the convenience store may be set aside for the sale of beer and wine. For purposes of determining the allowable beer and wine sales area, the licensee shall submit a floor plan of the convenience store at the time of application for the license. Areas of the convenience store, to which access by customers is prohibited, shall not be counted in the floor area calculation."

SECTION 2: That Title 11, Chapter 112, Section 112.14(A) of the Lombard Village Code is amended by adding an entry relative to a Class "ZZ" liquor license to read as follows:

"Class "ZZ" - \$750.00"

SECTION 3: That Title 11, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by adding an entry relative to the Class "ZZ" liquor license to read as follows:

"Class "ZZ" - 1"

This increase in Class "ZZ" liquor licenses reflects the issuance of a Class "ZZ" liquor license to Clark Retail Enterprises, Inc. d/b/a Road Pilot located at 18 W. 675 East Roosevelt Road, Lombard, Illinois.

SECTION 4: That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.






