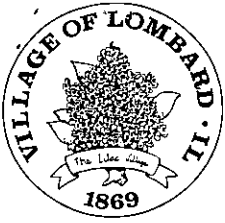

At the December 6, 2004, Transportation and Safety Committee meeting, the committee recommended the following items:

- Staff will continue to periodically monitor the intersection of Westmore/Meyers Road and Division Street for parking violations and accidents.
- Restrict vehicles over 5-tons on Edgewood Avenue from the north property line of the Westgate Lincoln Mercury dealership to Wilson Avenue.
- Convert the "Yield" control to a "Stop" control on Charlotte Street at Berkshire Avenue.
- Place removable stop signs on Berkshire Avenue in the middle of the crosswalks in the morning and afternoon when children are going to and from school.

The following sections of the traffic code require an ordinance:

**Add:** Schedule XIX – Section 10-15-3 - Five (5) Ton Vehicle Limit

Edgewood Avenue from 470 feet north of Route 38 to Wilson Avenue

**Delete:** Schedule V – Section 10-9-5 – Preferential Streets

Charlotte Street will yield to Berkshire Avenue

**Add:** Schedule IV – Section 10-9-4 – Stop Streets

Charlotte Street shall stop at Berkshire Avenue

**ORDINANCE AMENDING THE LOMBARD TRAFFIC CODE**

WHEREAS, the President and Board of Trustees of the Village of Lombard have heretofore passed and approved Ordinance 1186, An Ordinance Regulating Traffic in the Village of Lombard (hereinafter the Lombard Traffic Code); and

WHEREAS, the President and Board of Trustees of the Village of Lombard find that the Lombard Traffic Code has been amended from time to time; and

WHEREAS, the Transportation and Safety Committee has reviewed the appropriate traffic studies and recommends certain changes to the Lombard Traffic Code; and

WHEREAS, the Corporate Authorities of the Village of Lombard concur in the recommendation of the Transportation and Safety Committee.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, as follows:

Section 1: That Schedule XIX of the Lombard Traffic Code (Ordinance 1186) entitled FIVE (5) TON VEHICLE LIMIT be amended to add the following thereto:

Edgewood Avenue from 470 feet north of Route 38 to Wilson Avenue

Section 2: That Schedule V of the Lombard Traffic Code (Ordinance 1186) entitled PREFERENTIAL STREETS be amended to delete the following therefrom:

Charlotte Street will yield to Berkshire Avenue

Section 3: That Schedule IV of the Lombard Traffic Code (Ordinance 1186) entitled STOP STREETS be amended to add the following thereto:

<u>Name of Street</u>	<u>Shall Stop At</u>	<u>Name of Street</u>
Charlotte Street	“	Berkshire Avenue

Section 4: That this Ordinance shall be in full force and effect from and after its passage, approval, publication in pamphlet form and the posting of appropriate signs as provided by law.
