The Class "C" liquor classification allows beer and wine to be served as an adjunct to food service with no package sales allowed. Tsuki Sushi be a full service, dine-in restaurant offering Japanese cuisine.

**AN ORDINANCE AMENDING TITLE XI, CHAPTER 112,  
SECTION 112.13(A) OF THE LOMBARD VILLAGE CODE IN  
REGARD TO ALCOHOLIC BEVERAGES**

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES  
OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS** as follows:

Section 1: That Title XI, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the entry relative to the Class "C" liquor license, contained therein, to read as follows:

Class "C" - 7

This increase in Class "C" liquor licenses reflects the issuance of a Class "C" liquor license to Tsuki Sushi Inc. who will be operating the business commonly known as Tsuki Sushi located at 1005 E. St. Charles Road, Lombard.

Section 2: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
