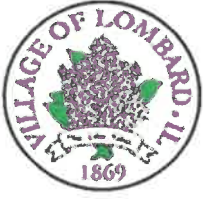

The Village received a request for a Class “EE” liquor license from GSBR CHI-Town LLC d/b/a Game Show Battle Rooms located at 2820 S. Highland, Unit A for the July 1 - December 31, 2023, license term.

Game Show Battle Rooms is an indoor amusement establishment that offers a variety of games shows for everyone to participate in and experience. The events can range from corporate team-building, sports teams, friend or family outings, birthdays and more. The owners are requesting to sell/serve canned beer, malt beverages and wine; also offering the guests the option to order catered food from restaurants in agreement with liquor licensee for delivery to the site and/or providing small, packaged snacks.

The Board of Trustees recently approved an Ordinance (8183) granting conditional use to the owners of Game Show Battle Rooms to operate as an indoor amusement establishment only on the property located in the B3 Community Shopping District, at 2820 S. Highland Ave., Unit A.

Attached is an ordinance amending Title XI, Chapter 112, Section 112.13(A) increasing the Class “EE” liquor license category by one and granting a liquor license to GSBR CHI-TOWN LLC d/b/a Game Show Battle Rooms, located at 2820 S. Highland Avenue, Unit A.

Staff is requesting a waiver of first reading to reflect the current number of licenses in the “EE” liquor license category.

ORDINANCE NO. _____

AN ORDINANCE AMENDING TITLE XI, CHAPTER 112, SECTION 112.13(A) OF THE LOMBARD VILLAGE CODE IN REGARD TO THE NUMBER OF CLASS "EE" LIQUOR LICENSES

BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

SECTION 1: That Title XI, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the language therein, relative to the Class "EE" liquor license category, to read in its entirety as follows:

"Class "EE" – 2"

This increase in the number of Class "EE" liquor licenses reflects the issuance of a new Class "EE" liquor license to GSBR CHI-TOWN LLC d/b/a Game Show Battle Rooms, located at 2820 S. Highland Avenue, Unit A, Lombard, Illinois.

SECTION 2: That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, as provided by law.
