**RESOLUTION ACCEPTING PUBLIC SIDEWALK, WATERMAIN AND FIRE  
HYDRANT AT 455 EAST BUTTERFIELD ROAD (MILLER'S ALE HOUSE), IN  
LOMBARD, ILLINOIS**

WHEREAS, the Private Engineering Services Division of the Village of Lombard has certified the completion of the public sidewalk, watermain and fire hydrant at 455 E. Butterfield Road (Miller's Ale House), and has recommended that said improvements be accepted; and

WHEREAS, the Corporate Authorities concur with said recommendation.

NOW, THEREFORE, BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: That the public improvements, as certified by the Private Engineering Services Division and as set forth on the approved engineering plans for the public sidewalk, watermain and fire hydrant at 455 E. Butterfield Road (Miller's Ale House), be and hereby are accepted for ownership by the Village of Lombard.

SECTION 2: That the on-site six-inch sanitary sewer, water service and fire suppression lines, and the entire storm sewer are to remain the responsibility of the property owner.

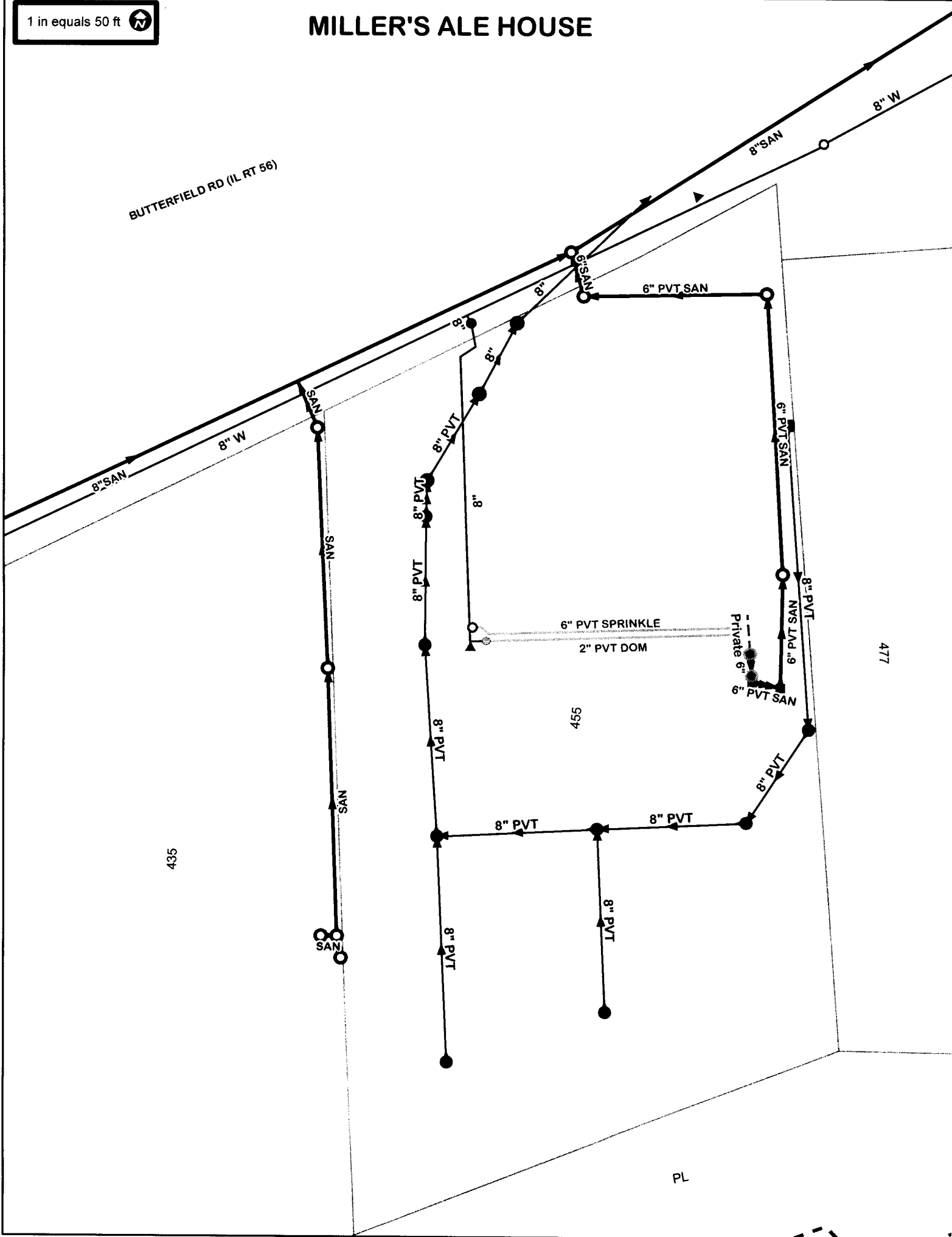
