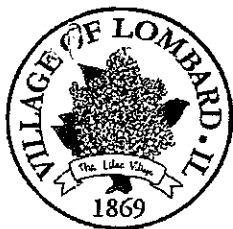

ORDINANCE _____

**AN ORDINANCE AMENDING TITLE 11, CHAPTER 112,
SECTION 112.13 OF THE LOMBARD VILLAGE CODE IN
REGARD TO ALCOHOLIC BEVERAGES**

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES
OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS** as follows:

Section 1: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the "Class O-I" liquor license, contained therein, to read as follows:

Class "O-I" - 2

This decrease in Class "O-I" liquor licenses reflects the termination of Select Hotels Group LLC d/b/a Hyatt Place and the termination of the Class "O-I" liquor license issued to Select Hotels Group LLC in relation thereto.

Section 2: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "O-I" liquor license, contained therein, to read as follows:

Class "O-I" - 3

This increase in Class "O-I" liquor licenses reflects the issuance of a Class "O-I" liquor license to Stanhope, LLC who is operating the business commonly known as Hyatt Place located at 2340 S. Fountain Square Drive, Lombard, IL.

Section 3: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
