FEMA IKE Grant

At the January 21, 2011 Village Board of Trustees meeting, the Board adopted three (3) resolutions in support of the Village's grant application for the Lift/Pump Station Improvement project. These projects are included in the FY2012 CIP in the amount of \$888,000. The projects are currently funded through Water & Sewer Capital Funds. The grant would cover \$750,000 of the projects costs, which would reduce the Village's contribution from the full \$888,000 to \$138,000. Resolution 64-11 stated that the Village Board of Trustees would commit \$50,000 towards the grant and not the \$138,000.

FEMA was requesting a resolution identifying the commitment by March 2, 2011. I spoke to the grant manager and advised that the funds were committed through the CIP, but that the next opportunity to take action on a revised resolution would be March 3, 2011. I was told that the March 3, 2011 meeting would satisfy FEMA.

I respectfully request that this item be placed on the agenda for the March 3, 2011 meeting.
